Pledge of Allegiance

Today is Tuesday, June 10, 2025, and the time being 6:30 pm. The meeting of the Greensburg City Council has been called to order.

Roll Call

Approval of Minutes

Minutes from May 13, 2025, were approved as presented.

Old Business

New Business

Bryan Robbins presented tax abatement renewals (CF-1 documents). The tax abatement committee recommended approval of each one submitted. Motion to approve CF-1's as presented made by Jamie Cain, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

Robbins noted that one business owner who has a current tax abatement was given until June 30th to begin the actual business. The committee intends to not renew the CF1 next year if the business is not operable. All incentives are an agreement between the City and the business owner.

Robbins also presented a new abatement for Haidlmair, an Austrian company proposing a \$7.2 million investment in the community. They estimate around 27 full-time employees with an average wage of around \$30 an hour. The site will be located off Liberty Circle in the 19-acre commerce park. They have submitted an SB1 for real property. Resolution 2025-13 is an agreement for a 9-year tax abatement for Haidlmair for real property. Motion to approve Resolution 2025-13 made by Jamie Cain, seconded by Mark Carman. Voice vote, all ayes no nays. Motion passes.

City Attorney Chris Stephen presented Ordinance 2025-08 Redistricting of Voting Districts. It was explained that even though the City had added three at-large districts in 2022 to comply with the statutory scheme, the ordinance did not include the words "recertify" or "redistrict". In 2024, a report identified Greensburg as one of the third-class cities that had not taken action regarding certification or redistricting. Ordinance 2025-08 would take care of recertifying the City of Greensburg. Stephen gave the option to the Council to keep precincts the same, but have a population deviation above the federal standard. Or change district lines to comply with the population deviation percentage. Motion to approve 2025-08 on first reading and include redistricting made by Jamie Cain, seconded by Rodney King. Voice vote, all ayes no nays. Motion passes.

Clerk Treasurer Amy Borns presented Ordinance 2025-07 which creates a fund for the upcoming INDOT grant for Traffic Signals. Motion to approve Ordinance 2025-07 on first reading made by Jamie Cain, seconded by Vietta McKenzie. Voice vote, all ayes no nays. Motion passes.

Motion to suspend the rules for Ordinance 2025-07 made by Jamie Cain, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

Motion to approve Ordinance 2025-07 on second reading made by Jamie Cain, seconded by Vietta McKenzie. Voice vote, all ayes no nays. Motion passes.

Borns also presented Resolution 2025-11 which would revive a dormant fund and rename it for the Rebekah Park Trail Grant. Motion to approve Resolution 2025-11 made by Jamie Cain, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

Street Commissioner Mark Klosterkemper gave an update on heavy trash. Approximately 670,000 pounds of trash were collected in five days; 75 tons mechanically and nearly half a million pounds collected by hand by 11 street department employees. This will be the only heavy trash day for this calendar year.

Director of Public Projects Zach Wirrig gave an update on the open house that was held at the old fire station and possibilities of interest in that site for renovation. Around 15-20 contractors, developers, and business people attended. There's hope in some interest in the project.

Wirrig gave updates on City projects. He also announced that a website has been launched with information on the Park Road project.

Council members gave updates on their respective boards and councils.

A special meeting will be held 5 pm June 24 for the second reading of Ordinance 2025-08.

Adjourn

Motion to adjourn made by Vietta McKenzie. Voice vote, all ayes no nays. Motion passes. Meeting adjourned at 7:29 PM.
