Motion to move opening of bids for CCMG 2024-01 to the top of the agenda made by Jamie Cain, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passes and the agenda is amended.

Zach Wirrig, Director of Public Projects, along with attorney Chris Stephen, opened bids for CCMG 2024-01. The bids are as follows:

Motion to conditionally grant the contract to Schutte Excavating made by Jamie Cain, seconded by Lauren Huber. Voice vote, all ayes no nays. Motion passes.

Scott Hadler of St. Mary's Church requested road closures for the On Eagle's Wings 5K annual event. This event will be in the morning on August 24, 2024. The road closures will be the same as previous years. Motion to approve the closures as presented made by Glenn Tebbe, seconded by Lauren Huber. Voice vote, all ayes no nays. Motion passes.

Wastewater Superintendent Zeke Smith presented a contract renewal with Christopher B. Burke Engineering for stormwater. The new contract is \$10,000 less than the previous one, and Smith's hope is

to have it be less moving forward as he and his team learn more and need Burke less. Motion to approve the agreement with Burke made by Robin Meyer, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Smith also presented a change order for the Vine Street project. There were additional charges due to four utilities lines that were unknown at the time of the work. Motion to approve the change order made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.

Smith presented Amendment No. 1 to Task Order 23-02 for the Vine Street project, which was an additional charge due to the redesign of the project after the findings of the utilities. Motion to approve Amendment No. 1 to Task Order 23-02 made by Glenn Tebbe, seconded by Lauren Huber. Voice vote, all ayes no nays. Motion passes.

Wirrig also gave an update on the Franklin Street reconstruction project. The bump-outs on each side of the street, as well as the curbs, have been completed. Activity is still on schedule.

Mayor Joshua Marsh gave an update on the Municipal Complex project. Most of the work is now being done on the inside. Fire alarm testing still needs to be done inside the Street Department building before moving in can happen for that department. For the fire station, the fascia is still to be installed as well as the elevator being installed inside the building. The elevator is on site, but they are still waiting on some electrical parts that should be there by July 22. At this time, the move in for this building will probably not be until August or September in order for it to be done, safe, and accessible.

Mayor Marsh announced that the October meeting will most likely be moved to October 2, pending the approval of the City Council.

Motion to approve claims as presented made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.
