### Pledge of Allegiance

Today is Tuesday, July 9, 2024, and the time being 6:30 pm. The meeting of the Greensburg City Council is called to order. At this time, please silence all electronic devices.

### Approval of Minutes

Minutes from June 11<sup>th</sup> were approved as presented.

### Old Business

Zach Wirrig, Director of Public Projects, presented Ordinance 2024-11 Amendment of Parking Chapter for its second reading. Motion to approve Ordinance 2024-11 on second reading made by Rodney King, seconded by Daryl Tressler. Voice vote, all ayes no nays. Motion passes.

Wirrig proposed postponing Ordinance 2024-12 Parking Restrictions for the second reading until next month due to several public comments that led him to acknowledge that it needs to be looked into further.

Christa Dickson of 1706 N Nieman Drive spoke on this topic stating that this has not been an issue in the past other than recently when there was a community garage sale along with trash and recycling day. James Stewart of 1659 W Trimble Street spoke in favor of parking on only one side of the street. He has watched several large vehicles (Street Department vehicles and school buses included) have trouble making their way through the streets because of parking on both sides. Motion to table Ordinance 2024-12 made by Darrell Poling, seconded by Mark Carman. Voice vote, all ayes no nays. Motion passes.

### New Business

Mayor Joshua Marsh gave an update on the Municipal Complex project. Most of the work is now being done on the inside. Fire alarm testing still needs to be done inside the Street Department building before moving in can happen for that department. For the fire station, the fascia is still to be installed as well as the elevator

being installed inside the building. The elevator is on site, but they are still waiting on some electrical parts that should be there by July 22. At this time, the move in for this building will probably not be until August or September in order for it to be done, safe, and accessible.

Erin Thomas, executive director of LifeTime Resources, presented an update on the Area Agency on Aging. Part of her presentation was also a request for a \$10,000 contribution from the City, which is a \$5,000 increase from previous years. This contribution is specifically for Catch-a-Ride in Decatur County. Motion to contribute \$10,000 to Catch-a-Ride made by Darrell Poling, seconded by Rodney King. Voice vote, Daryl Tressler – aye, Vietta McKenzie – aye, Mark Carman – nay, Jamie Cain – nay, Rodney King – aye, Darrell Poling – aye. Motion passes with a vote of 4-2.

City Clerk Treasurer Amy Borns presented Ordinance 2024-13 Additional Appropriation for Airport Operations for its first reading. Motion to approve Ordinance 2024-13 on first reading made by Jamie Cain, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

The Council members took turns giving updates on their respective boards and commissions.

Mayor Marsh commended the Water Department for their work this past month, as they have had several water main breaks.

Mayor Marsh also asked for the Council to choose a date for the first reading of the 2025 budget. The Council agreed on August 5 at 5:30 pm here at City Hall.

Mayor Marsh also asked that the October meeting be changed to October 2 due to scheduling conflicts. The Council agreed on that date.

Motion to adjourn made by Vietta McKenzie. Voice vote, all ayes no nays. Motion passes. Meeting adjourned at 7:19 PM
