## Pledge of Allegiance

# **Approve Minutes**

Minutes for July 9 regular meeting and the August 5 Special Meeting for budget planning were approved as presented.

### **Public Hearing**

Motion to open the public hearing made by Kevin Fleetwood, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Public hearing opened at 6:31 PM.

The public hearing is for Ordinance 2024-14 vacation of alleys around the Methodist Church. Zach Wirrig, Director of Public Projects, spoke about this ordinance. He said that vacating these alleys would connect the church to the properties they own on the other sides of the alleys.

Deborah Reese spoke as a representative for the church. The church would like to put speed bumps in the alleys as a matter of safety to pedestrians, bike riders, etc. Tony Reese also spoke about the blind spot created by the building on the corner of the alley.

Chief Stoermer did not have any issues with this plan and did not feel it would affect public safety vehicles getting to where they need to go.

Motion to close public hearing made by Jamie Cain, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

Regular meeting resumes at 6:37 pm.

#### **Old Business**

Zach Wirrig, Director of Public Projects, presented Ordinance 2024-12 for Parking Restrictions for second reading. He explained that after much discussion between Street Commissioner Mark Klosterkemper, Legal Counsel Chris Stephen, and himself, it was decided that a resolution would be presented with all the changes that need to be made for the parking restrictions. The Council wanted to wait until they see the resolution before they made a final decision on the ordinance. Motion to table 2024-12 until next month when the resolution that will accompany the parking restrictions will be presented made by Jamie Cain, seconded by Vietta McKenzie. Additional discussion was had about the timing of the implementation of these restrictions and how many comments Wirrig has received about this topic. Wirrig stated that the signage and enforcement would take several weeks after passing the ordinance. He stated that he has received comments, mostly positive because people know there is limited space to move through the streets when parking is on both sides. Voice vote, 6 ayes 1 nay. Motion passes.

Clerk Treasurer Amy Borns presented Ordinance 2024-13 for Additional Appropriation for Airport Operations for second reading. Motion to approve Ordinance 2024-13 on second reading made by Jamie Cain, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

#### **New Business**

Matt Mason from the Veridus Group presented an update on the Municipal Project. He announced that both buildings are very close to completion. Site work is completed, street, landscaping, etc. Furniture has been installed in the Street Department. Two outstanding work items are still to be completed on the Fire Station. The elevator installation is finally completed as of today. The hope is that final inspections happen this week. September 14 is set for the open house for the public for both buildings.

Fire Chief Nathan Stoermer and Fire Inspector Alan Campbell presented a change in fire inspection fees and fines. The hope is that this change will encourage business owners to make sure their fire safety equipment is accurate, active, and up to date. The Council gave support to Inspector Campbell to move forward with creating an ordinance with a fine and fee schedule. President Cain also requested that there be an appeals process in place when the ordinance is created.

Zach Wirrig presented Ordinance 2024-14 Alley Vacation for Methodist Church for first reading. Motion to approve Ordinance 2024-14 on first reading made by Darrell Poling, seconded by Mark Carman. Voice vote, all ayes no nays. Motion passes.

Motion to suspend the rules for Ordinance 2024-14 made by Kevin Fleetwood, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Motion to pass Ordinance 2024-14 on second reading made by Jamie Cain, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

Mayor Joshua Marsh reminded the Council that they need to nominate a representative to the DCCF Lilly Scholarship Selection Committee. Mark Carman made a motion to nominate Dr. Rodney King as representative if he is inclined to do so (Dr. King agreed), seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Council members gave updates on their respective boards and commissions.

Water Superintendent Rick Denney gave an update on projects the water department is planning for the rest of the year. These are projects will be submitted to SRF for the use of those funds. The water main from 4<sup>th</sup> Street to across the bypass and from Broadway to Lincoln will be replaced. There are several sections of water mains that need to be replaced that will help with water flow.

Mayor Marsh reminded everyone that next week is heavy trash week.
