Approve Minutes

Motion to approve the minutes from the July 11, 2023, meeting made by Lindsay Jobe, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passed.

New Business

Mayor Marsh presented an update on the Municipal Complex Project from Veridus Group. Footings and foundation have begun for both the fire station and street department. The project is still on schedule and within budget.

Mike McNealy, Police Chief, requested support for the replacement of a police vehicle. The vehicle was deemed "no longer usable" by the City's insurance company. He asked for a 2023 Chevy Tahoe as well as the equipment to outfit it. Motion to approve the purchase, provided the City Council's approval of the additional appropriation, made by Glenn Tebbe, seconded by Rodney King. Voice vote, all ayes no nays. Motion passed.

Chief McNealy invited everyone to National Night Out taking place August 17 at 5:00 pm at North Park.

David Roszell, Assistant Fire Chief, requested an approval of conditional offer to candidate number 3. Motion to approve the conditional offer as presented made by Glenn Tebbe, seconded by Rodney King. Voice vote, all ayes no nays. Motion passed.

Donna Lecher, Utilities Manager, presented a sewer adjustment request for account number 2678830 for an amount of \$1,693.38 for an underground leak. Motion to approve the request as presented made by Jamie Cain, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passed.

Zeke Smith, Wastewater Superintendent, discussed the award of the South Vine Street Sewer project. Bryce Foderman of Strand Associates joined Smith to discuss the project and bids. Only one bid was received for the project at a significantly higher price than expected, per the engineer's specs and cost evaluation. At this point, they are looking at changing the timeline for this project in the hopes of receiving more competitive bids. The intention is to start the process over completely, including readvertising and re-bidding. Motion to reject all bids received for this project made by Lindsay Jobe, seconded by Rodney King. Voice vote, all ayes no nays. Motion passed.

Smith also gave an update on the Franklin Street project. A manhole was backing up and had to be repaired due to roots growing into the pipe. Several proposals were received, and eventually the project was awarded to Dave O'Mara Contractor. The issue was taken care of within about 3 days.

Smith presented quotes for a new Equipment building. Currently, there are several pieces of expensive equipment that must sit out in the elements. The building is needed to keep the equipment in good condition. Three quotes were received, with Homan coming in lowest at \$142,500. Motion to approve the bid from Homan made by Lindsay Jobe, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passed.

Ron May, City Engineer, presented a contract from Strand Associates for a new set of City Design Standards. The contract will be split between the City and the Utilities. Motion to approve the contract as presented made by Lindsay Jobe, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passed.

Mayor Joshua Marsh announced that Heavy Trash Week will be August 21-25.

Motion to approve the claims as presented made by Lindsay Jobe, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passed.

Mayor Marsh announced that City Engineer Ron May will be retiring at the end of the year and wanted to thank him for his service throughout the years. There will be a celebration later in the year for Engineer May.
