Pledge of Allegiance

Today is Tuesday, September 3, 2025, and the time being 5:30 pm. The meeting of the Greensburg Board of Works has been called to order.

Roll Call

Approval of Minutes

Minutes from the August 12 regular meeting and August 26 Executive Session were approved as presented.

Old Business

Mayor Marsh presented an updated contract from the Washington Township Board. There was discussion as to whether the Board would reject the contract or table the matter due to vague language that needs to be clarified. Motion to approve the contract as presented made by Jamie Cain, seconded by Lauren Barnhorst. Voice vote, no ayes all nays (0-4). Motion dies, contract not approved.

New Business

Fire Chief Nathan Stoermer requested approval of purchase for a fire apparatus. This is a used apparatus and needed temporarily while waiting on the mid-mount aerial that is on order but will not arrive until 2027. Stoermer is seeking approval to inspect and purchase the apparatus. He is asking for a not-to-exceed purchase amount of \$130,000. The cost would also include the freight cost to get it shipped here. Motion to approve authorization of the purchase of the apparatus, including outfitting, freight, minor repairs, and decals, of up to \$130,000 made by Glenn Tebbe, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Chief Stoermer also presented a contract for a radio upgrade. State of Indiana has a new mandate, without a hard start date, to upgrade radios to P2. The quote is \$72,366.25. This will put all new radios that would meet the mandate in all vehicles. Motion to approve the purchase of the upgraded radios as presented made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.

Director of Public Projects Zach Wirrig presented an update on current city projects. Milling and paving for the downtown square should be finished by this weekend. O'Mara will continue to finish work on Broadway, 1st Street, and a few other areas in the following weeks.

Motion to approve the claims as presented made by Glenn Tebbe, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.
