Mike McNealy, Police Chief, requested destruction of assets - list of equipment (unusable items or metal/steel); looking for approval to destroy or recycle. Motion to approval request made by Rodney King, seconded by Karen D. Rust. Voice vote: Jamie Cain – yes, Rodney King – yes, Glenn Tebbe – yes, Karen D. Rust – yes. Motion passes.

Chief McNealy also made a recommendation for an unusable vehicle - 2010 Ford Crown Victoria, which is no longer usable as body mounts have rusted out, as well as steering issues. The Board expressed reticence in selling due to the condition of the vehicle. The suggestion was utilizing it in training for the fire department. Motion made to donate vehicle to fire department for training and subsequently destroyed and taken to recycling facility made by Rodney King, seconded by Karen D. Rust. Fire Chief Nathan Stoermer presented a change of personnel classification. There was one resignation, however, they do have 23 applicants. The application window closes at the end of May. The fire department hopes to have an executive session in early June to hire a new firefighter. Requesting a status change from Recruit Firefighter to Private Firefighter for Cory Fischer after completing his probation year of training. Chief Stoermer also announced the choice of the fire station task force committee for the design firm for the new fire station project. Motion to approve DLZ as the design firm for the fire station project, pending approval by the City Council, made by Rodney King, seconded by Glenn Tebbe. Street Commissioner Mark Klosterkemper presented an interlocal agreement for Park Road Project. The City was awarded \$2.6 million for the Park Road Project. INDOT insisted on an interlocal agreement between the City and the County, with the City taking the lead in the project. Motion to approve the Interlocal Agreement for Park Road Project made by Karen D. Rust, seconded by Rodney King. Jamie Cain – yes, Rodney King – yes, Glenn Tebbe – yes, Karen D. Rust – yes. City Engineer Ron May presented quotes for the demolition of 430 N Monfort Street, which was a property severely damaged in a fire several months ago. Motion to approve the contract with Best Excavating for \$15,000 made by Karen D. Rust, seconded by Glenn Tebbe. Jamie Cain – yes, Rodney King – yes, Glenn Tebbe – yes, Karen D. Rust – yes. Engineer May also presented the final contract payout for CPM construction for the City Hall renovation project. No motion was needed to approve because this invoice is already posted on the docket that will be approved later in the meeting.

Engineer May presented a wastewater utility commitment letter for the proposed Decatur County Highway Department stating that the City will provide wastewater utilities to the new building. Motion to approve the Mayor to sign the letter committing the City to provide wastewater services to the County Highway Department made by Glenn Tebbe, seconded by Rodney King. Amy Borns, City Clerk Treasurer, did a quick review of the State Board of Accounts Audit for the year of 2020 that was just completed. One of the items brought up during the audit, that has been repeated in previous audits, is the lack of a capital asset inventory, which should be done every two years. Clerk Treasurer Borns looked into companies that do this type of work and received two proposals. One from Jon Peterson and one from Larry Tippin. Motion made to accept the contract proposed by Jon Peterson to complete a Capital Asset Inventory for the City in conjunction with the Clerk Treasurer's office made by Rodney King, seconded by Karen D. Mayor Joshua Marsh presented the GIS Consultant contract with Christopher B. Burke Engineering which would help with assistance to our current GIS department. Motion to approve on-call services contract with Christopher B. Burke Engineering for an assistance program for the City's GIS Department made by Karen D. Rust, seconded by Glenn Tebbe.
