Brendan Bridges, Chief of Greensburg Police Department

Chief Bridges stated interviews for new hires for the Police Department had been held and requested approval to hire. Motion to approve by Rodney King; second by Karen D Rust; voice vote recorded all ayes no nays; motion passed.

Chief Bridges stated that in a prior ordinance article 34.06 A> Any policeman who retires after having served at least 20 years on the Police Department, is authorized to retain his standard four-inch service weapon. Chief Bridges requested permission to present retiring Greensburg Police Office Dave Wilson his revolver and have it removed from the Firearms Inventory; motion to approve by Jamie Cain; second by Karen D Rust: voice vote recorded all ayes no nays; motion passed.

Motion was made by Jamie Cain to approve said purchase with a spending cap not to exceed \$3675.00, second Glenn Tebbe; voice vote recorded all ayes no nays; motion passed.

Mayor Marsh presented Resolution 2020-2 to amend city, police and fire personnel handbook and request the Board of Works to send to the City Council with their recommendation to approve. Motion made to recommend approval to the Council with the inclusion of exhibit A by Glenn Tebbe, second by Rodney King; voice vote recorded all ayes no nays; motion passed.

Mayor Marsh requested to purchase additional fob scanners for the Water Utility Office. Requested tabled.

Mayor Marsh requested permission to invite bids for a city website rebuild. Glenn Tebbe stated there is no reason for the Mayor not to proceed.

Ron May stated Veterans Way phase 2 project last right of way parcel has been secured. He further reported that the design consultant has proposed an amendment to the design contract that would increase design fees in the amount of \$12,900.00 and that the re-development commission had agreed to pay that additional amount. Ron May requested that the Board Of Works enter into the agreement to pay. Motion made by Glenn Tebbe to accept the agreement second Jamie Cain; voice vote recorded all ayes no nays; motion passed.
