It was duly noted that future meeting would be held at the new location, 315 S Ireland, Greensburg known as the old Washington School.

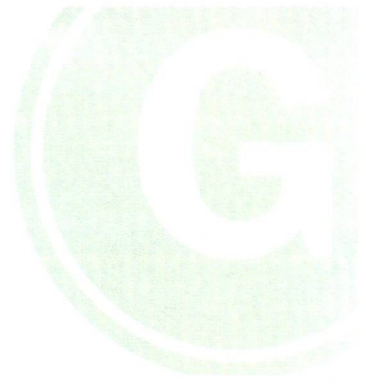
Motion to adjourn by Rick Emsweller. All Ayes. No time recorded.
