

**ORDINANCE 2022-09**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GREENSBURG, INDIANA,  
AMENDING § 71.11(A) and §71.11(B) RELATED TO UTV SIDE BY SIDE VEHICLE  
USAGE AND REGISTRATION**

WHEREAS, the City Council (“Council”) of the City of Greensburg, Indiana (“City” or “Greensburg”) previously established an ordinance allowing for certain UTV Side By Side Vehicle Usage on Greensburg Roadways under Amended Ordinance 2019-40 passed on March 2, 2020 and codified at § 71.11 (collectively, the “Original UTV Code”);

WHEREAS, section 1 of the Original UTV Code as set forth in § 71.11(A) provides in pertinent part that “UTV side by side vehicles . . . are hereby allowed on streets of Greensburg, excluding state highways . . .”; and

WHEREAS, Indiana Code 9-21-1-3.3 permits a city, county, or town to adopt an ordinance to permit the use of UTV’s on a highway; and

WHEREAS, §71.11(B) provides that all UTV’s must be registered annually but does not set a deadline for such registration; and

WHEREAS, the City has determined that a specific annual registration date would be beneficial to the efficiency and operation of the Ordinance;

WHEREAS, the Council finds that it is in the best interest of the City to permit use of UTV side by side vehicles on highways located in and around the City of Greensburg in accordance with Ind Code 9-21-1-3.3 and to register all UTV’s by no later than June 1 of each calendar year.


NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Greensburg, Indiana, as follows:

1. Code Chapter § 71.11(A) shall be amended to read as follows: “Subject to the regulations contained in this ordinance, UTV side by side vehicles as defined by I.C. 14-8-22-233.5, are, under authority as set forth in Ind Code 9-21-1-3.3, are hereby allowed to operate on all highways and streets in the City of Greensburg subject to the conditions set forth in this section. 4-wheelers are not allowed on the streets of Greensburg.
2. The first sentence of Code Chapter §71.11(B) shall be amended to read as follows: UTV side by side vehicles must be registered annually with the City of Greensburg with such annual registration being performed by the Greensburg Police Department by no later than June 1<sup>st</sup> of each calendar year.” The remaining text of §71.11(B) shall remain unchanged.
3. All other Code Chapters not specifically amended herein shall remain in full force and effect without change or amendment.


Introduced on April 12, 2022, and adopted by the City Council of the City of Greensburg, Indiana, on May 10, 2022.
