## **Water Board Meeting**

- **Member Recognition** – Robin Meyer presented a plaque of appreciation to past Board Member Charles “Chuck” Storie’s widow, Jane, for his years of service on the Water Board: June 1985-February 2021.
- **HNTB Update** – Darren Burkhardt gave a verbal and visual New Surface Water Plant update stating that they are fully moved into the new plant. Darren also gave a recap of the April 5<sup>th</sup> water main break, estimating the water loss being 3.5-5 MG’s and noted the repairs were made with great group effort.
- **Lawn Mower Bids** – Rick Denney presented quotes for a new mower, replacing the 5-year-old John Deere ZTR, from: Tri-County Outdoor Power \$6,799.00, Stone’s Farm Service, Inc. \$5,979.00 & Nobbe Mower Shop, Inc. \$5,100.00-delivery by 6/1/2021). **Motion made by Frank, seconded by Tony to approve the quote from Stone’s Farm Service, Inc. in the amount of \$5,979.00 for a Kubota. Roll call vote all ayes and motion carried.**
- **Hach Contract** – Rick Denney presented a quote from Hach for quarterly testing/calibration of testing and analyzing equipment; annual fee \$21,561.00. **Motion was made by Robin to approve the quote from Hach, second by Frank, roll call vote all ayes and motion carried.**

Rick updated the Board on the status of odor in the water: as of today, on day 8 of bypassing Upland Reservoir and using Flatrock as our main water source and noted we can treat muddy water with the new plant and said as of now, we have the best water since he has been Superintendent (26 years); we will have the 180 MG reservoir on standby.
