

**VisitGreenvilleSC presents the
Greenville, SC Taco Trail and Taco Trail Sweepstakes
OFFICIAL RULES**

NO PAYMENT, ENTRY FEE, OR PURCHASE REQUIRED. SUPPORTING EACH RESTAURANT LISTED IN THE TACO TRAIL IS ENCOURAGED.

- 1. HOW IT WORKS:** Participants must get a Greenville, SC Taco Trail (“Taco Trail”) Passport (“Passport”) and visit up to twelve (12) restaurants listed in the Passport. Upon visiting each restaurant on the Taco Trail, participants must write down the corresponding codeword(s) in their Passport. Prizes will be awarded for completing various levels of the Taco Trail as listed within the Prize Details & Conditions below. Limit one (1) Passport per person. Upon redeeming a completed Passport with all twelve (12) codewords prior to April 15, 2023, participant will be entered in the Taco Trail Sweepstakes (“Sweepstakes”) for a chance to win two (2) free VIP tickets to the 2023 Tacos ‘N Tequila Festival in Traveler’s Rest, SC (“Grand Prize”).
- 2. ELIGIBILITY:** Taco Trail participants must be at least eighteen (18) years old or have permission from a parent or legal guardian. Grand Prize winners must be at least twenty-one (21) years old per the official Tacos ‘N Tequila Festival rules. If Sweepstakes winners are under the age of twenty-one (21), a prize of equal or lesser value will be substituted. All Taco Trail and Sweepstakes participants must be legal residents of the forty-eight (48) contiguous united states, and the District of Columbia (excluding Alaska, Hawaii, Puerto Rico, Guam, and the U.S. Virgin Islands and other territories). PRIZE: Level One** - Participants with four (4) Taco Trail codewords in their Passport will receive one (1) Taco Trail sticker. **Level Two** - Participants with eight (8) Taco Trail codewords in their Passport will receive one (1) Taco Trail tumbler in addition to the Level One prize. **Level Three** – Participants with all twelve (12) Taco Trail in their Passport will receive one (1) Taco Trail baseball hat in addition to the Level One and Level Two prizes. Participants redeeming a Passport with all twelve (12) codewords prior to April 15, 2023, will be entered in the Sweepstakes, where two (2) entrants will be randomly selected to win two (2) free VIP tickets to the 2023 Tacos ‘N Tequila Festival in Traveler’s Rest, SC.
- 4. PRIZE DETAILS & CONDITIONS:** Participants will receive one (1) prize per level of completion of the Taco Trail. Participants must acquire no fewer than four (4)

codewords for the Level One prize, no fewer than eight (8) codewords for the Level Two prize, and no fewer than twelve (12) codewords for the Level Three prize and Sweepstakes entry. A VisitGreenvilleSC representative at the VisitGreenvilleSC Visitor Center ("Visitor Center") will stamp, mark, or otherwise indicate the level(s) of Taco Trail completion on the Passport. Partially completed Passports may not be duplicated, falsely marked, or otherwise tampered with in order to receive additional prizes and/or Sweepstakes entry. Participants must be able to travel to the Visitor Center located at 206 S. Main Street, Greenville, South Carolina 29601 to redeem their prize(s). If participant is unable to travel to the Visitor Center and does not reside in Greenville County within South Carolina, they may email visit@visitgreenvillesc.com for support, and their prize(s) may be shipped to them via FedEx Ground. If submitting a completed Passport and entering the Sweepstakes, adequate contact information must also be provided, including, but not limited to: Full Name, Email, Phone Number, and Shipping Address. Approximate Retail Value (ARV) of Taco Trail prizes is \$30 USD. Approximate Retail Value (ARV) of Sweepstakes prize per winner is \$160 USD. If it is impossible to reach the selected by email within forty-eight (48) hours after the draw, all rights to the Grand Prize will be forfeited and another entry will be drawn. If it is impossible to reach the second selected by email within forty-eight (48) hours of the draw of the second entry, all rights to the Grand Prize will be forfeited and another entry will be drawn. If it is impossible to reach the third selected by email within forty-eight (48) hours of the draw of the third entry, the Grand Prize will be forfeited.

By participating in the Taco Trail, you also authorize VisitGreenvilleSC and Taco Trail Entities to provide your personal information to third party fulfillment companies so that such companies may process you as the recipient of the prize(s).

- 7. TACO TRAIL & SWEEPSTAKES CONDITIONS:** The Taco Trail and Sweepstakes are subject to all applicable federal, state, and local laws. Participants agree to be bound by these Official Rules and the decisions of VisitGreenvilleSC and waive any right to claim ambiguity in the Taco Trail, Sweepstakes, or these Official Rules. DISPUTES:** Except where prohibited, entrant agrees that: any and all disputes, claims and causes of action arising out of or connected with this Taco Trail or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court of the state of South Carolina. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and VisitGreenvilleSC in connection with the Taco Trail, shall be governed by, and construed in accordance with, the laws of the State of South Carolina. Without giving effect to any choice of law or conflict of law rules (whether of the State of South Carolina or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of South Carolina. In the event of a dispute over the terms of these rules or the Taco Trail, the parties agree to the exclusive jurisdiction of the state and/or federal courts in Greenville County, South Carolina, and courts with appellate jurisdiction over such courts, and agree that venue therein is proper and convenient.
