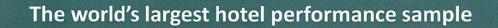

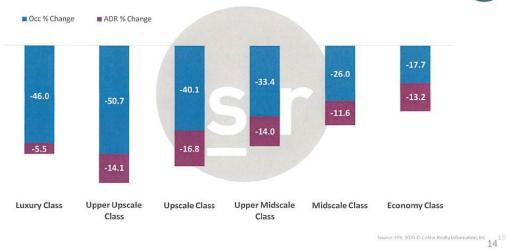

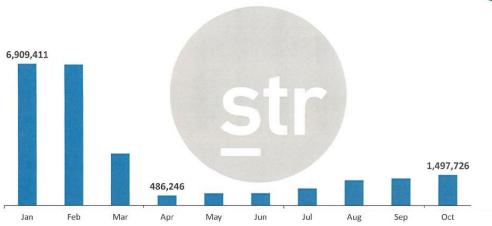




## **Group Demand Starts The Long, Slow Climb Back**

Group Rooms Sold, Lux & UU classes, by month





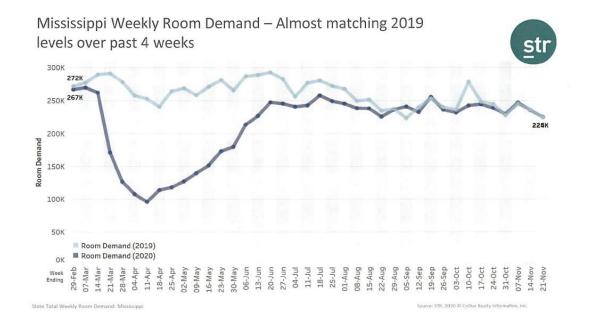


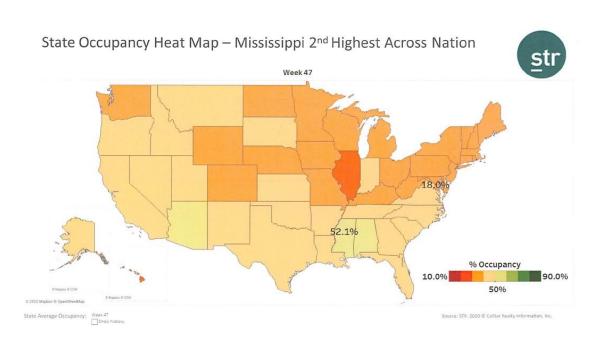

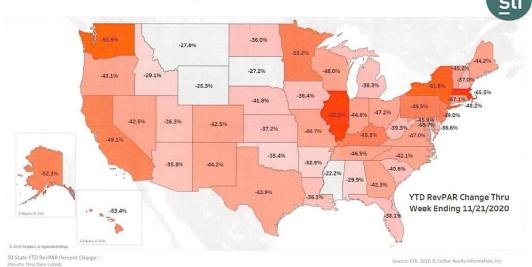

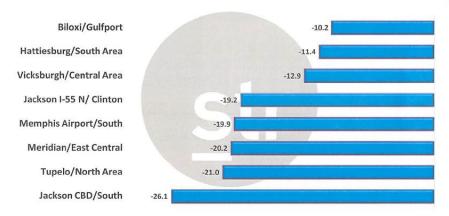


### Year To Date RevPAR Changes Across The Nation



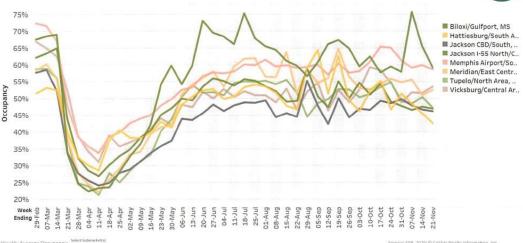
### Occupancy Declines "Less Bad" in Coastal / Southern Areas





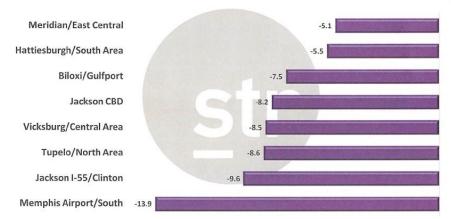
### Weekly Occupancy by Mississippi Submarkets





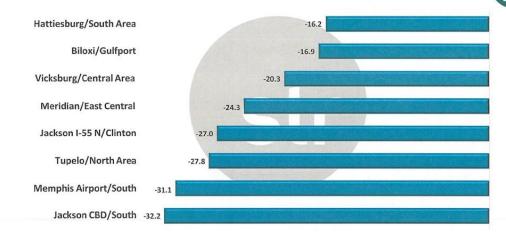

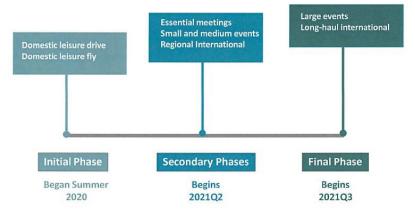
