VISIT HERSHEY & HARRISBURG LICENSING AGREEMENT FOR MEDIA USE OF IMAGES/VIDEO

PLEASE READ THIS AGREEMENT CAREFULLY. The following terms and conditions collectively govern use of all Content available from VHH, and constitutes a binding Agreement between <u>ANY WORKING MEDIA</u>, <u>WRITER, REPORTER, PUBLICATION, MEDIA OUTLET, ONLINE PUBLISHER or WEBSITE/BLOG</u>, <u>(YOU) WHO RECEIVE IMAGES FROM VISIT HERSHEY & HARRISBURG (VHH)</u>, a Pennsylvania Corporation with offices at 3211 North Front Street, Suite 301-A, Harrisburg, PA 17110. By signing below, or by using any Content from VHH, You agree to be bound by and comply with all of the terms of this Agreement.

1. **DEFINITIONS**

- **1.1** "<u>Content</u>" means any images, including any accompanying text, in the form of, without limitation, images, photographs, illustrations, film or video footage, audio product, or any visual representation which is licensed to You by VHH under the terms of this Agreement.
- **1.2** "<u>End Use</u>" means use of the Content for the sole purpose of owned marketing and public relations channels controlled by You (such as email, websites and social media).
- **1.3** "<u>**Reproduce**</u>" means any form of copying or publication of the whole or a part of any Content, via any medium and by whatever means.
- **1.4** "<u>Term</u>" means with respect to this Agreement, the Term shall end on the earlier to occur of (i) termination or cancellation of the Agreement as provided herein or (ii) the expiration of this Agreement.
- **1.5** "<u>You</u>" means the legal entity entering into this Agreement or any employee or contractor on behalf of such legal entity that edits, manipulates or modifies the Content. You shall only use the Content in accordance with the terms of this Agreement.

2. LICENSE GRANT

- 2.1 <u>License Grant</u>: Subject to the terms and conditions of the Agreement, VHH grants You a limited, non-exclusive license to use the Content for the sole purpose of the End Use for the Term.
- **2.2** <u>Restrictions</u>: Your use of the Content is strictly limited by the terms of this Agreement. Other than the End Use, Content may not be sold or sublicensed alone or as part of any product or service. In addition, You may NOT:
 - (I) Sublicense, publish, display, distribute, perform, or use in any way the Content that is not specifically and expressly stated in this Agreement, including, without limitation, the End Use after the Term.
 - (II) Copy or Reproduce the Content, except as incorporated into the End Use.
 - (III) Remove any copyright, trademark, watermark or other notice from any place where it appears on the Content.
 - (IV) Assign, sell, rent, loan, give or otherwise transfer any Content or rights to the content, except as provided herein.
 - (V) Use Content in a defamatory or otherwise unlawful End Use, including without limitation violating any person's right of privacy, publicity, or moral rights, or to infringing upon any copyright, trade name or trademark of any person or entity.

2.3 <u>**Ownership**</u>: VHH retains all right, title and interest in and to the Content, including without limitation, the copyrights. No other rights in any Content are granted to You except the limited license specified in this Agreement. You do not acquire, and shall not claim, any rights (trademark, copyright or otherwise) in or to the Content itself apart from the End Use.

3. WARRANTY, DISCLAIMER, AND EXCLUSION OF LIABILITY

NEITHER VHH NOR ANY OF ITS EMPLOYEES WARRANT THAT VHH CONTENT WILL BE ERROR FREE. VHH MAKES NO REPRESENTATION, GUARANTEE OR WARRANTY AS TO THE SCOPE OR VALIDITY OF ANY INTELLECTUAL PROPERTY RIGHTS OR THAT YOUR USE OF THE CONTENT SHALL BE FREE FROM INFRINGEMENT OF ANY INTELLECTUAL PROPERTY RIGHTS HELD BY THIRD PARTIES. VHH INCURS NO OBLIGATION OR LIABILITY FOR BRINGING ACTIONS AGAINST THIRD PARTIES FOR ALLEGED INTELLECTUAL PROPERTY RIGHTS INFRINGEMENT WITHIN THE SCOPE OF THIS AGREEMENT OR FOR DEFENDING YOU AGAINST THE SAME.

4. TERM/TERMINATION

- **4.1** <u>**Term:**</u> This Agreement will take effect from the date on which VHH accepts the Agreement and makes the Content available to You.
- **4.2** <u>**Termination**</u>: This Agreement terminates immediately and without the need for notice if You breach Your obligations under this Agreement. In addition, VHH may terminate this Agreement at any time, in its sole discretion, by written notice to You with immediate effect.

5. GOVERNING LAW

This Agreement and the rights of the parties are governed by the laws of the Commonwealth of Pennsylvania. You consent to the exclusive jurisdiction of the courts located in Dauphin County, Pennsylvania, in connection with any action or proceeding related to this Agreement.
