2. If you require an HMCC certified electrician to connect your equipment or special work to be done regarding your electrical service, you must call (828) 328-1335 to make arrangements in advance.
3. All material and equipment furnished by an HMCC certified electrician shall remain at the Center after close of the show. If material and equipment is taken, the ordering Exhibitor will incur a fee for the replacement of those items.
4. Should you fail to make advance arrangements for an HMCC certified electrician to connect equipment or perform special work, HMCC does not guarantee that an electrician will be available to perform special work and provide connection to your electrical drop.
5. If your electrical drops need to be in a specific location in the booth, please attach a layout of drop locations. Failure to do so may result in additional fees if you request a new location for your drop.
6. HMCC does not rent or provide extension cords for exhibitor use. All exhibitor extension cords used must be at least 16 gauge, grounded and UL Listed.
