Incredible Impacts Grant - Round 1 Questions

This document outlines the questions during Round 1 of the application process, to assist with preparing your submission. Please submit your application by Tuesday 2 June 2026, 11:59PM CET.

Please consider these questions to check if your project is a good fit for the Incredible Impacts Programme and which grant you should apply for?

1. **Is your legacy or impact programme directly linked to a specific international association meeting or congress?**

If your answer is **no**, your project would not be eligible. If your answer is **yes**, move on to question 2.

2. **Has the event already taken place?**

If your answer is **no** the [Seed Fund Grant](#) is likely the best fit as it supports upcoming event and early-stage legacy initiatives. If your answer is **yes**, move on to question 3.

3. **Was the legacy or impact programme intentionally planned as part of the event strategy, rather than added on afterwards?**

If your answer is **no**, the Incredible Impacts Programme focuses on legacy initiatives that are embedded in the event strategy and will need to demonstrate this in your application. If your answer is **yes**, move on to the final question.

4. **Do you have outcomes, results, or clear evidence of impact that you can already share?**

If your answer is **no**, the [Seed Fund Grant](#) may be a better fit at this stage. If your answer is **yes**, you can apply for the [Main Grant](#).

- What is the role of the local convention bureau in planning, executing and measuring the long-lasting impact of the legacy project?
- What measuring tools do you have in place to monitor and report on the short-mid- and long terms impacts of your legacy activity? (Entries providing a systematic effort to measure and report on their impact will receive bonus points towards their entry.)
