

## IGLTA OFFICIAL SWEEPSTAKES RULES

### **“Hotel Giveaway”**

*All rules must be read before entering.*

#### **1. Eligibility**

SWEEPSTAKES OPEN TO EVERYONE WHO IS EIGHTEEN YEARS (18) OF AGE OR OLDER as of the date of the initiation of the registration. Directors, officers, and employees of IGLTA (the “Sponsor”) and Hotel Unique and any of its respective affiliate companies, subsidiaries, agents, professional advisors, associates, sponsors, advertising and promotional agencies, and immediate families of each are not eligible to win a prize.
