# IRVING CONVENTION AND VISITORS BUREAU MINUTES – COMMUNITY RELATIONS COMMITTEE MEETING IRVING CONVENTION CENTER AT LAS COLINAS TUESDAY, FEBRUARY 16, 2018

Those present for the meeting were: Rick Lindsey, Committee Chair; Karen Cooperstein, Committee Vice Chair; Bob Bettis; Bob Bourgeois, Jo-Ann Bresowar - Committee Members. Staff: Maura Gast, Carol Boyer, Diana Pfaff and Carol Stoddard.

Committee Chair Rick Lindsey called the meeting to order at 9:01 a.m.

High Spirited Citizen nominations were reviewed for Jim and Virginia Meler. Jim Meler may not be in good health and the Committee would like to present the High Spirited Award to the Melers at City Council as soon as possible, if accepted. On a motion from Committee Vice Chair Karen Cooperstein, and second from Board member Bob Bourgeois, the nomination of Jim and Virginia Meler was unanimously approved to bring forward to the full Board of Directors for approval.

The nomination for Debra Cox was reviewed and discussion was held. Her volunteer contributions and community input were reviewed. On a motion from Committee Vice Chair Karen Cooperstein, and a second from Board Member Bob Bettis, the nomination of Debra Cox was unanimously approved to bring forward to the full Board of Directors for approval.

Assuming the full Board's approval, presentations will be scheduled with the Mayor's office. A request will be made to present the award to the Melers at the next City Council meeting, and all Board members will be encouraged to attend. Previously approved awards to Marilyn and Joe Willems and Willie Cole will be scheduled with the Mayor's office and will be staggered based on availability every other month. It was agreed if other nominations are received, there would be availability for one or two additions before the end of the calendar year. Executive Director Maura Gast commented a nomination for Jearlene Miller is anticipated from Mary Higbie and Patty Landers but has not yet been received.

Discussion was held on getting the word out for new nominations. It was suggested that a letter with the nomination form to Irving churches and mosques to solicit active volunteers could merit good candidates. The City's neighborhood roundtables were also suggested. Board member Jo-Ann Bresowar commended people who are nominating candidates and commented there is a lot of hard work that goes into the nomination process. ICVB Assistant Executive Director/Marketing and Communications Diana Pfaff noted the need for age diversity and younger nominees that are involved in the community. Bourgeois added the older community is a resource to assist in recruiting younger volunteers. Cooperstein suggested a "Rising Star" award for the younger community involved nominees. Gast noted to add a brainstorming session to the next Committee agenda for the "Rising Star" award.

In response to a question from Lindsey, ICVB Marketing Coordinator Carol Stoddard was tasked with researching Jackie Townsell's sisters and their volunteer involvement, as well as their resident status. Cooperstein also suggested a nomination of Lourdes and Luis Spinola.

Pfaff reported the 30<sup>th</sup> anniversary for the High Spirited Citizen award is approaching and the Committee want to discuss possibilities for a celebration. Bresowar suggested inviting previous awardees to the event. Discussion was also held on reinstating "Breakfast with the Mayor," possibly on an annual basis with each year's awardees.

Pfaff noted Donna and Bob Bourgeois will be recognized at the February 26 Board meeting for their High Spirited Citizen award.

With no further questions, Lindsey adjourned the meeting at 9:31 a.m.
