Chair Clem Lear called the meeting to order at 11:47 a.m.

ELECTION OF OFFICERS

Board Member Debbi Haacke nominated Chair Clem Lear for a second term as Chair of the ICVB Board of Directors, with a second from Board Member Jo-Ann Bresowar. Haacke stated Lear's professionalism and leadership has been a great asset to the Board, and with the new developments in Irving and legislative direction in the Board's strategic plan, Lear is a great choice to lead the Board in to this legislative session year. With no other nominations, Lear was unanimously approved as Chair for a second term.

Board Member Bresowar nominated Vice Chair Ron Mathai for a second term, with a second from Board Member David Cole. Bresowar noted his assistance to the Board and to the Chair and his involvement in Board activities and professionalism. With no other nominations, Mathai was unanimously approved as Vice Chair for a second term.

CONSENT AGENDA:

Lear asked for a motion to accept the Consent Agenda as presented. Bresowar made a motion to accept; second by Board Member Karen Cooperstein. With no opposition and no further discussion, the Consent Agenda was unanimously approved.

4. ACCEPTING THE ICC AUDIT RESULTS 2017-18

Lear introduced Laura Edwards from Crowe, who reviewed the revised financial packet that was distributed as a handout. Edwards noted the independent auditor report that describes the audit in accordance to the contractual basis between the City of Irving and SMG. The audit received the highest level of assurance with an unqualified opinion. Edwards further reviewed the balance sheet and noted the \$305,281 being returned to the ICVB in the capital improvement fund. She noted the only item requiring judgment is for allowance for doubtful event, but there was none to report at year-end. It was a clean audit and received the highest audit opinion. There were not any matters to report to the Board. Haacke noted it is important to recognize the team accomplished \$10 million in revenue and should be congratulated for their efforts. Lear asked for a motion to accept the ICC audit results. Board Member Rick Lindsey made a motion, with a second from Haacke. With no further opposition and no further discussion, the motion was unanimously approved.

Cole asked if all City Council members receive a copy of the audit report, and Executive Director Maura Gast replied they had not in the past. Cole suggested they receive a copy for review.

INDIVIDUAL CONSIDERATION:

5. APPROVING BUDGET ADJUSTMENT TRANSFER OF \$305,281

Lear asked for a motion to approve the Budget Adjustment Transfer of \$305,281, achieved as a result in the financial performance of the Irving Convention Center. Haacke made a motion to approve, with a second from Cooperstein. With no further opposition and no further discussion, the motion was unanimously approved.

6. 2019 LEGISLATIVE AGENDA TOURISM PUBLIC IMPROVEMENT DISTRICT

Gast noted an article on page 52 of the Board packet, referencing the City of Frisco's pursuit of the TPID, and added that Dallas, Arlington, and Fort Worth all have the legislation in effect. As was discussed during the Board's strategic planning process and adopted as part of the final plan, the TPID will allow for additional marketing and booking incentives to generate greater visitor revenues. The ICVB will pursue having Irving included in the next legislative session and working through the Hotel Association to put a plan together. The item will be added to the December 13 City Council meeting agenda. Gast noted the legislation currently is crafted and set based on population. Lear suggested all Board members read the article and get clarification if needed.

BOARD CHAIR REPORT

Lear introduced Convention Services Associate Helena Walsh, who is receiving her five-year service award. Gast noted she and her husband, Bert, are both part of the Convention Services team. Walsh is a great part of the team and often covers the CVB front desk. She brings great joy to everything she does. Senior Convention Services Manager Wendy Foster and Lear presented the award to Walsh with congratulations from the full Board.

Lear echoed previous comments on congratulations to the ICVB and ICC staff for an outstanding year. She noted the increase in media and social media spots. She also congratulated Gast on being awarded the Top 25 Women in the Meetings Industry by Northstar Meetings Group.

Lear thanked the Board and CVB staff for the recent High Spirited Citizen 30th Anniversary Celebration. She commented on the beautiful Christmas and holiday decorations around Irving and the Convention Center. She reminded the Board of the City holiday parade and open house on December 1, and the Toyota Music Factory tree lighting on December 2. She noted the next Executive Committee meeting is scheduled for Friday, December 13, and the Board meeting will be held on Monday, December 17. The Irving Hospitality Industry Annual Meeting will be held at the Convention Center on February 15.

BOARD DEVELOPMENT COMMITTEE

Committee Chair Haacke reported the Committee is focused on several programs from the strategic plan that will be helpful to the CVB. Haacke, Gast, Lear and Cooperstein participated in the North Texas Legislative Summit on October 15. The next Board Development Committee meeting will be held on December 7 at the Irving Convention Center at 9:00 a.m. Discussion will be held to consider a potential Committee name change to more accurately reflect their priorities and responsibilities, along with the planning and execution of the strategic plan. The Committee will be represented at the Irving-Las Colinas Chamber of Commerce legislative send-off on Wednesday, December 12.

COMMUNITY ENGAGEMENT COMMITTEE

Committee Chair Lindsey reported the High Spirited Citizen 30th Anniversary celebration was a great success and recognized over 400 program participants. The event hosted over 100 people, of which 65 were High Spirited Citizens. Glory House catered the event and did a fantastic job of making the occasion special. Mayor Stopfer presented a proclamation to Board Chair Lear. It was an honor for all who attended. Lindsey thanked Pfaff and team for a job well done. He reminded the Board of the holiday parade on December 1 and the High Spirited Citizens will ride in a horse-drawn wagon. If anyone wishes to participate, a waiver form needs to be completed and returned in advance. The next Community Engagement Committee meeting date is to be determined and will be communicated later.

DESTINATION DEVELOPMENT COMMITTEE

Committee Chair Greg Malcolm reported the Committee met on November 6 and had an informative and interesting tour of Texas Live! and the downtown Arlington, Texas area, along with a presentation about the project by the Arlington CVB. The next Destination Development Committee meeting date is to be determined and will be communicated later.

CITY REPORTS

Mayor Rick Stopfer reported economic development and retention are priorities for the City. Irving has more Fortune 500 companies per capita than any other city in the United States. He noted the City's website has a breakdown of new developments in the eight Irving corridors and shows the districts and developments that have been submitted and in process. He recommended everyone look at the website and review the page to realize how development is spread across the City. He further noted: several hotel construction projects are moving forward; Pioneer development is looking great and they are focused on environmental development; Hwy 183/114/Loop 12 construction is going well, and the Diamond Interchange construction will be starting soon. He also commented on the growth and development in schools in our area. The museum and downtown Irving area re-development is moving forward, recreation facilities are having over \$1 million in renovations, and the City is on track with golf course and Heritage Park renovations to be sure they are updated with what our residents need.

Stopfer reported on issues with the levees when the lakes are drained, and it raises water levels, and water needs to be treated at the treatment plant. The treatment plant uses tons of chlorine for water treatment and there was a delay in chlorine delivery, which caused a breakdown. There was miscommunication between government entities and an investigation is being conducted on the City for spillage. There was a sewage pipe back up in the Valley Ranch area and lines are being installed. He congratulated the City staff and their ability to be ready and step in to fix issues when needed.

Stopfer reported that DART is focused on the Cotton Belt and environmental clearance has been approved. The RIF loan should be in place and enable the project to move forward. Next on the DART agenda will be the BNSF railroad from downtown to Farmers Branch, Carrollton and out to Frisco. It is an important project to be able to bring the connection through Irving.

City Manager Chris Hillman introduced Assistant City Manager Philip Sanders, who comes with over two decades in economic development and experience. He will be a great partner with the Chamber and the Planning and Zoning Committee. He noted the great economic development efforts and partnership with the Chamber. He reported the TIF extension was completed and approved at the last City Council meeting for another 20 years. He thanked Board Member Jacky Knox, Board Member John Haigler, the Mayor and City Council for their efforts. He gave special thanks to Chief Financial Officer Jeff Litchfield, who put together several presentations and analyses for the project. Hillman reported the second Irving 360 class has graduated and he is looking forward to next year's class. There was good feedback from the participants and the City will regularly reach out to them to continue to engage them in the City. Hillman distributed a pocket-sized card with all the City's hotline phone numbers for reference, including one for potholes. In response to a question from Cooperstein, he directed calls regarding feral hogs be referred to the City's Animal Services Department.

Litchfield gave an update on the Hotel Occupancy Tax Audit. A presentation was given on the subject to the October 17 Audit and Finance Committee. The City does quarterly hotel occupancy tax collections. An audit was done with 22 hotels, with 13 or 59% in reported deficiencies, totaling \$110,164. Additionally, one hotel may be owed a refund. Nine hotels will receive letters of commendation with no issues reported, and 13 hotels have received letters of deficiency. To date 25% of those deficiencies has been collected. The next round of audits has been started on a quarterly, four-year cycle. Gast clarified the \$110,164 was over a four-year period. After the four-year cycle, an evaluation will be conducted to determine continuation of the audit. In response to a question from Bresowar, Litchfield stated a hotel can be added back into an audit any time there is cause for concern. He added consistency will be important going forward. Vice Chair Ron Mathai asked about the standard penalty, and Litchfield replied it runs between \$2,000 and \$2,200 per audited hotel property.

BUREAU MANAGEMENT AND STAFF

Lear congratulated Assistant Executive Director/Marketing and Communications Diana Pfaff for her involvement as Chair of the recent Irving Schools Foundation benefit, and noted she is also on the Board of the DFW Humane Society, which hosted its Black Collar Affair recently. She congratulated Pfaff for her leadership and input on these Irving charity events. She also noted the Irving Salvation Army Super Lunch will be held on December 11 at the Irving Convention Center with Carol Boyer as chair and encouraged everyone to purchase tickets. She congratulated the CVB staff on their charity efforts, along with their outstanding regular jobs.

Gast reported for Assistant Executive Director/Sales and Services Lori Fojtasek and noted the September 2018 year-end Sales report on page 70 of the Board packet. She reminded that going forward into the current fiscal year as was discussed during the budget presentation, sales will be weaning off airline crew incentives to preserve limited business development incentive funds for traditional group bookings.

Gast shared a Save the Date invitation on December 13 for a joint meeting with City Council, Irving-Las Colinas Chamber, and the CVB Board to hear David M. Sander, Ph.D discuss issues faced by inner ring or first tier suburbs and the potential problems and opportunities they face, which will be worthwhile information for Boards and Commissions to have.

Pfaff reported the year-end numbers for Marketing and Communications are off the chart. Digital RFPs are the highest to date with 418,109 associated room nights, and 62% of room nights. Website traffic increased to an all-time high of 485,925 total sessions and 376,542 total users visiting both websites, which is a 59% increase over last year. The newly redesigned blog has 60,000 page views for the year. Advertising engagement increased, largely due to Marketing Director Monty White's efforts and ended the year with 50,120 advertising impressions, 14,775 site visits, a 632% increase in impressions over the previous year and a 196% gain in site visits. Google AdWords paid search campaign is performing well with 623,838 impressions, 69,317 site visits that accounted for 116 RFPs. This was a 223% increase in site visits and 50% in RFPs over last year.

Pfaff reported earned media ended the year with just over 1 billion media impressions and a public relations value just over \$20 million. The CVB co-sponsored with the Chamber at the Park Place Luxury and Super Car Show at the Four Seasons Resort in October, and also partnered with the Four Seasons for a press trip with several high-end writers during the event. An article has already been published from the press tour in <u>Paper City</u> and it is included in the Board packet. She added the article for Gast's recognition in the 2018 Top 25 Women in the Meetings Industry is also included, as well as the Taste of the Toyota Music Factory social media influencer recap. She added congratulations to Marketing Manager Kayla Mansour, who handles the social media posts, on the birth of a baby boy.

Assistant Executive Director/Administration & Finance Mike Zumbaugh reviewed the September STR report, noting the October data had not been received as of the meeting date. He reported Irving's Occupancy is higher than Texas and the United States at 74.4%. September's Occupancy is down compared to last year. He believes Texas numbers are down due to Hurricane Harvey last year. Average Daily Rate in Irving was \$109.03, up 2.3% in September compared to last year. From the AirBNB data, he reported there were 289 active listings in Irving, which is a 49.75% increase over last year's figure of 193. The hotel comparable subset reported the YTD average daily rate through September of \$88.17, up 8.0% over last year, with YTD occupancy of 64.0%, up 10.8% from last year. Bresowar asked if there is tracking of AirBNBs and Gast said there has been discussion at Council committees on what is happening and how to license them, what is the volume and what is the amount of money being left on the table. She replied the CVB is using the STR and AirDNA reports to be prepared as best we can as the City continues to research this issue. Other cities in the Dallas-Fort Worth area have attempted to regulate them and have had the law overturned. The State legislature will likely take its own actions this upcoming session that may determine how the city will be able to move forward.

He reported Accounting Director Marianne Lauda has wrapped up year-end numbers and has been fully engaged in the training and conversion efforts of the new accounting software at the City.

CONVENTION CENTER

General Manager Tom Meehan reported it was another great year, as noted in the audit report. He thanked Edwards and the team from Crowe and expressed his appreciation for their partnership each year. He reported the ICC has returned over \$300,000 to the CVB this year in performance savings and noted this is the first year Convention Center's gross revenue has gone over \$10 million. Of that significant number, 60% is from Food and Beverage. He attributed the success to Executive Chef Eduardo Alvarez and his team to make that possible. He reported the building is going through some repair projects, starting with carpet replacement on Level 4. The third-floor carpet replacement will come later this year.

Director of Sales Matt Tungett reported October had a good start for the new fiscal year with 21 events booked. Fan Days numbers were up over last year, and the return of University of Dallas after a brief hiatus was a big win. Both events have rebooked for future dates. The ICC and CVB held a joint local sales blitz with 81 appointments over five days with good outcomes. Meehan and Tungett are hosting holiday luncheons in Austin and attending a national sales meeting in New Orleans. He congratulated ICC Sales Managers Aleese McMahen, Casey Villaseñor, and Collista Garcia for recording the highest shop call scores for the SMG organization.

INDUSTRY AND BOARD PARTNERS

HOTEL REPORTS

Malcolm reviewed Revenue Per Available Room (RevPAR) and reported October was up \$90.47, which equates to a 2.4% increase in Occupancy. November is pacing behind, and he is hoping December will be better.

Board Member Kim Limon reported November is up in Average Daily Rate 5.2%, finishing 1.9% up for the month. RevPAR is up 9.9% for the year, but down in November and December is unpredictable.

Board Member Holly Turner reported staffing updates, and announced new Director of Sales Melissa Malone, and new culinary team with Executive Chef Peter Andino from the W in downtown Dallas, and new Executive Sous Chef Raphael Bravo. The Omni will continue with wonderful food and beverage programs and excited to see what the new teams will bring.

RESTAURANT REPORT

Board Member David Cole reported the protection of customers in the recent romaine lettuce recall is number one for health and safety. Restaurants are taking it seriously and customers are unhappy. Hopefully, the recall will end shortly with no outbreaks.

DCURD

Board Member Jacky Knox reported upstream releases from USACE lakes are expected to continue through December. The Lake Carolyn storm water pump station emergency generator project design engineering is complete. The bidding process will begin in January to award a contract by February 2019. The project is scheduled for construction completion in one year. The project is a critical component of flood control protection for Lake Carolyn and the Urban Center areas. The cost is estimated to be \$10 million and is funded by the current TIF #1 term. Williams Square updating and redesign continues to move forward. Three of the four public meetings have been held. An APT study is scheduled to commence in February. The focus of the study is to review new and existing technology that can utilize the existing APT infrastructure for expansion of services. The existing TIF #1 funding is integral to the various waterway maintenance projects, as well as the previously mentioned projects. The extension will enable a continuation of and provision for much needed future infrastructure maintenance and improvements. Valley Ranch sump improvements are scheduled to be complete within the next 60 days. The current phase of Cowboy Canal Wall replacement is in progress. IFCD I east and west cell levees received a USACE approval of the recently completed 408 Project, which removes those levees from a de-certified status.

IRVING-LAS COLINAS CHAMBER OF COMMERCE

Chamber President Beth Bowman reported on behalf of Chamber Chair Lars Rosene. Rosene is working in California with crisis communication for non-profits to locate and care for animals caught in the current fire events. Bowman gave a recap of the mid-term elections and impact on Irving with new representation. The Chamber's Legislative Send-Off is scheduled for December 12 from 4:30 – 6:00 p.m. at the Las Colinas Country Club. The majority are freshman representation Senator-elect Nathan Johnson, Representative-elect Julie Johnson, Representative-elect Terry Meza, Representative-elect Jessica Gonzalez and returning Senator Kelly Hancock, Senator Royce West and Representative Rafael Anchia. Bowman encouraged everyone to attend the send-off and continue to educate our legislative representatives on Irving, Texas.

Economic Development reported 22 recruitment wins that created 2,359 job opportunities and \$308 million in capital investments. The team successfully had 14 retention expansion wins, projects generating \$104 million in new investment. There were 36 total project wins, with 3,800 jobs to Irving, with more than \$412 million in capital investment. Fiscal year 2018 results represent a 154% return on the City of Irving's public investment into economic development services provided by the Chamber. Bowman congratulated the economic development team for record numbers and Chamber partners in keeping assets home in Irving. Irving's unemployment dropped 3.3% down from 3.4% in July. Texas and National rates are 3.9%. The Chamber will host a cyber-security roundtable on December 5 and encouraged all to attend. She expressed her gratitude to work with the CVB, Irving Arts, University of Dallas and local non-profits to bring the third annual Share Tank program together, and winners will be announced on December 14. The State of the City will be held on January 29 at the Irving Convention Center.

IRVING ARTS CENTER

Executive Director Todd Hawkins congratulated the CVB Board Chair and Vice Chair on their re-elections and reported Judy Pierson was also nominated for the Chair of the Irving Arts Board for another year. He reported the Irving museum project is moving forward and the construction contract has been authorized by the City Council. He reported input will be received from strategic planning for the museum and permanent exhibition. The Ruth Paine house was recently showcased on the Travel Channel television series "Mysteries at the Museum." The 26th annual holiday decorating program is underway at the Irving Arts Center and Board members are invited to be judges for the Lone Star Christmas contest. Voting will take place through December 3. "Two Step Your Way Through Time in Historic Texas Dance Halls" is open December 1. The Holiday Open House is on December 7, with a free concert from Ryders in the Sky at 7:30 p.m. and the winners of the Lone Star Christmas contest. will be announced.

TIF REPORT

Board Member John Haigler reported the November 15 City Council approved the TIF #1 extension for 20 years. DCURD will receive \$9 million, which will leave \$60-64 million for economic development and reimbursement dollars. The reimbursement to the ARK Group of \$44 million is scheduled to be paid before the end of the year, and he believes the ARK Group is on target for the project completion. The Council also approved an amended and restated interlocal agreement between the City and DCURD concerning desiltation of district waterways and other public infrastructure projects.

LAS COLINAS ASSOCIATION REPORT

Board Member Hammond Perot noted his one-year anniversary of being here in Irving and on this Board. The economy is doing well, and he anticipates that to keep moving forward. In average, 48,000 people that live in Las Colinas and 40% of that are from Pan Asia, 50% of that number are foreign-born. Las Colinas continues to grow and be a highly diverse community. There is still 70% vacant office space and LCA will continue to look at how to recruit new tenants to the area. Strategic planning will continue to focus on the Urban Center and include wayfinding. The designs for a dog park are underway and expected to start construction next summer. Phase I of a branding exercise is compete, which reviewed designs to ensure walkability and sustainability, and changing of signs in the community, and will now start the process to redefine and hone-in on the brand going forward. It is expected to be a five-year plan and be completed in conjunction with the LCA's 50th anniversary "Jubilee" celebration. He announced the return of the charity bowl-a-thon this year, and looking to add a 5K run in October, and some additional new events to the Urban Center. He reported original neighborhoods with fixed income revenues continue to be a challenge to maintain. The LCA is looking at working with homeowners in a pilot program to help with maintaining those properties.

City Secretary Shanae Jennings gave the oath of office and swearing in of returning ICVB Board Members Bob Bettis, Jo-Ann Bresowar, Debbi Haacke, Greg Malcolm, Ron Mathai, and Joe Philipp.

With no further discussion, Lear adjourned the meeting at 1:54 p.m.





Midtown Express Project Update

Massive \$850 million, 27.8 mile, Midtown Express project is almost complete.

The project — which includes three roadways: State Highway 183, State Highway 114 and Loop 12 — passes through five cities: Bedford, Euless, Fort Worth, Irving and Dallas in Tarrant and Dallas counties. It is anticipated to be finished by the end of the year.

Portions of general-purpose lanes and frontage roads were reconstructed in the project, and TEXpress lanes were built on all three roadways. At the heart of the project were improvements to SH 183, which was built in 1959 and has been relatively unchanged since 1973, when an additional mainlane in each direction was added. One of the biggest challenges facing the team during construction was keeping traffic flowing through this major corridor. The project had more than 12,000 lane closures and 173 traffic switches, with the team working 24 hours a day, seven days a week. Much of the work was phased or performed overnight to minimize effects on peak-time traffic.

The project required rehabilitation of 44 bridges, building 26 new bridges and completing four direct-connect ramps. Crews set 1,869 bridge beams and moved 2.7 million cubic yards of dirt and 47 miles of utilities. Once the entire project is complete, the team will have worked more than 4 million man-hours using 800 pieces of construction equipment, including 240 vehicles, 18 bulldozers and 26 excavators.

The Texas Department of Transportation opened the TEXpress lanes on SH 114 last fall and opened additional TEXpress lanes on SH 183 and Loop 12 in October. The TEXpress lanes operate 24 hours a day, seven days a week and provide drivers an option. Motorist can choose to take the mainlanes at no cost or pay to use the TEXpress lanes. Until early 2019, pricing will follow an approved fixed toll rate schedule. After the fixedrate period, traffic speeds will be managed through dynamic pricing, meaning the price will fluctuate based on congestion in the TEXpress lanes. High occupancy vehicles (HOVs) and motorcycle drivers with a valid toll tag who register and activate their HOV status at DriveOnTEXpress.com or through a mobile app (Drive On TEXpress), can receive a 50 percent discount during

FLU SEASON IS HERE

The Centers for Disease Control and Prevention (CDC) says to expect flu activity to ramp up just in time for the holidays and run through late spring.

The CDC recommends that people get their flu vaccinations now, before the heavy influenza onset arrives.

Irving Fire Department Chief Victor Conley believes everyone should be vaccinated. "People give many reasons for not getting a flu vaccination. One of the most common we hear is they believe the vaccination gives them the flu," said Conley.

The CDC says the vaccine does not cause the flu. However, it is possible to have a mild reaction to the vaccine — a low-grade fever or mild headache.

"I think the real reason, quite frankly, is a fear of needles," Conley said. "I tell people the few seconds of discomfort from the shot beats days and days of feeling miserable while they try to cope with fever, cough, headaches, body aches and extreme fatigue."

The flu can be particularly difficult for at-risk populations, such as small children and people over age 65.

Irving residents can be vaccinated at their doctors' offices, as well as at various pharmacies around the city. Dallas County Health and Human Services provides a number of low-cost immunization clinics. The locations can be found on the agency's website at DallasCounty.org/ HHS.

Save a Homeless Pet's Life by Fostering

A few months ago, Archie could fit in the palm of a hand.

The 1-day-old puppy was abandoned at the Irving Animal Care Campus in August. Too young to stay at the shelter, a foster volunteer took Archie home to provide the love and round-the-clock care he needed to grow.

An Irving Animal Services (IAS) foster saved Archie. He is now a 4-month-old spunky pup in a home of his own. Fosters also help shelter animals that need:

- Time to recover from surgery or illness.
- Bottle-feeding.
- Some training or socialization.
- Heartworm treatment.

Fostering Benefits All

Fostering a shelter animal benefits the pet and shelter. When a shelter animal goes to a foster home, Irving Animal Care Campus (IACC) has a vacancy to rescue another homeless animal.

The foster program is a short-term commitment that carries no fees or expenses. IAS covers medical costs and basic supplies such as a collar, leash, food and medication. The shelter environment can be stressful for some animals, and bringing them to a home setting is what they need to blossom. Foster pet parents can see firsthand the pet's personality and in turn help the animal find a compatible family.

Additionally, animals in the foster program have the opportunity to socialize in an environment that has children, more than one pet, or provides interaction with different animals. These are factors that can help increase the pet's chances of being adopted. For

Whether placing at the curb or dropping off, residents must remove all obstructions, such as tree stands, lights, tinsel, nails and ornaments. All plastic bags covering the tree also must be removed.

The city offers residents the following tips to assist in preparing for inclement weather and staying safe.

Winter Weather Safety Tips:

- Wear several layers of loose-fitting, lightweight, warm clothing instead of one heavy layer.
- Ensure that outer garments are water-repellent.
- Ensure heating sources are working properly and that they are well ventilated. It is important to have them serviced regularly.
- Avoid driving on overpasses and bridges. These often freeze more quickly than roads.
- Winterize all vehicles. Flush the cooling system, replace the coolant, the wiper blades, etc.
- Prepare a "Go Kit" (blanket, gloves, hat, etc.) for the vehicle in the event of being stranded.
- Insulate outside faucets and pipes; keep inside faucets dripping when the temperature falls below freezing.
- Ensure animals have plenty of food, water and shelter for extreme weather conditions.
- Check on the elderly and children during this time as they can be extra vulnerable to cold weather.

Cooler Temperatures Call for Less Irrigation

Residents may now water lawns between 10 a.m. and 6 p.m. on assigned watering days. Each year, time-of-day watering restrictions are scheduled to ease between Nov. 1 and April 1 so that residents may water during what is typically the warmest time of the day. It is important to avoid irrigating when temperatures approach the freezing mark, which often occurs at night.

While time-of-day restrictions provide guidelines that optimize irrigation, it is important to know that lawns (dormant turf grass) do not require any irrigation during cooler months. Shrubs and trees need water only every 4 to 6 weeks. Irrigation systems should be turned off completely and operated manually only if there is no precipitation for more than four weeks.

Designated watering days are assigned based on street addresses as follows: odd addresses irrigate on Sunday and Wednesday; even addresses water on Tuesday and Saturday. Watering is always prohibited on Monday, Thursday and Friday. Water conservation outside is just as important in the winter as it is in warmer months. See the following tips:

- Plants that are irrigated in the evening and remain wet all night are more likely to develop fungal problems.
- Irrigating during any form of precipitation is prohibited by city ordinance.
- Irrigation systems should be turned off to prevent accidental activation which could cause dangerous ice on streets and walkways.
- If hand-washing vehicles, use a bucket and sponge; rinse with a hose using a positive shut-off nozzle.

Indoor water conservation should include the following:

- Installation of low-flow shower heads and faucets, as well as faucet aerators to reduce water use.
- Repairing leaks from dripping faucets and running toilets can save water and can reduce water bill.
- Run only full loads when using the dishwasher.


MARTIN LUTHER KING JR. 2019 OBSERVANCE

City Makes Emergency Repairs on Brockbank Channel after Heavy Fall Rain Storms



Fall brought an unprecedented amount of rain across North Texas. But with the cooler temperatures and much needed moisture, excessive water runoff caused damage across the region, including Irving's Brockbank Channel.

The City of Irving Traffic and Transportation Department's Streets Division made expeditious repairs to a damaged portion of the channel, saving both time and money. The \$25,000 project saved the city nearly \$120,000 by using an in-house crew rather than procuring an outside vendor. The project also helped protect residents' homes and property.

Assessing the damage

After the late September rains that washed through the Dallas-Fort Worth area, Streets Division crew members reviewed infrastructure throughout the city. During their assessment, crews noticed that an area of the Brockbank Channel had taken the brunt of the increased water runoff.

The runoff damaged the drainage structure, causing a 5- to 6-foot-deep hole along the channel floor, as well as cracks and erosion to the channel walls. As more rain loomed in the forecast, crews set a plan in place with the necessary staff, equipment and materials to complete the job.

Repair and rebuild

A new concrete mixing truck and equipment, that provides on-site production of concrete, played a big role in the repairs. Funding for purchase of the equipment was included in the Fiscal Year 2017-18 budget, and City Council approved the purchase in December 2017. With the help of the concrete mixing truck, Streets' crews were able to repair the channel on-site as needed, as well as use the necessary amount of concrete. This critical piece of equipment provided crews a cost-efficient, reliable source for concrete delivery.

Crews worked quickly over the course of two days to rebuild the channel floor and to rebuild and reinforce the channel walls. In addition to the restructured concrete walls, crews laid 120 bags of cement, weighing 100 pounds each, on top of the wall to secure the property from possible future erosion.

The reconstruction of the Brockbank Channel, phase 3, will include this entire area as part of a four-phase drainage channel improvement project along the Delaware Creek Basin. Project bids have been awarded and construction will begin in December. The project is slated for completion in 2021.

Quick facts

The City of Irving Streets Division took immediate action to repair a fractured area of Brockbank Channel. Here is what it took to complete the \$25,000 emergency repair project:

- 100 cubic yards of cementitious flex base (gravel and cement mixed) or the equivalent of 10 truckloads of material.
- 90 cubic yards of concrete produced using the city's newest concrete mixing truck.
- 12,000 pounds of cement bags positioned above the channel wall.
- 15 Streets Division employees
- Two full days of work
- More than 300 man-hours

- equipment, food scrapers and brooms.
- Keep grease out of wash water; place food scraps in the trash.
- Flush only toilet paper and human waste down toilet.
- Dispose of towels, diapers, all wipes and cleaning cloths, and feminine products in the trash.
- Recycle used oil through the city's Special Waste Collection program. For more information, call (972) 721-8059.

DO NOT:

- Pour oil or grease down drains; always place used oil in a container and dispose of it in the trash.
- Use hot water to rinse grease from any surface.
- Allow food scraps down the drain.
- Flush disposable or "flushable" cleaning cloths, wipes, diapers, feminine products or paper towels down the toilet.

Mulching Leaves Keeps Nutrients in the Soil

Cooler weather equals falling leaves, and lawns and gardens will benefit from proper leaf management.

Correct Leaf Management

The best leaf management is to mow and mulch leaves into the turf. Using a mulching mower is best but not essential. Turf can take a large volume of leaves before there is excess. Excess leaves would be when the lawn is about to be completely covered and smothered by the ground-up leaves.

At the point of excess, the leaves should still be mulched on the lawn or driveway, and then raked, picked up and distributed as mulch in flower beds and vegetable gardens.

When no more mulch is needed in the flower and vegetable beds, the remaining ground-up leaves can be added to a compost pile. Add dry molasses (approximately 20 pounds per 1,000 square feet) to the beds and the compost pile to help the material break down and become humus more efficiently.

Leaf Management Mistakes

- Do not bag leaves and send them to the landfill.
- Do not rake leaves and set them on fire.
- Do not rake leaves and put into the compost pile, leaving them whole, except as a last resort.
- Do not blow leaves onto a neighbor's property or into the storm drains or streets.
- If there are too many clippings, rake them into mulch layers around trees and shrubbery.

Leaves are Excellent for Mulch

Mulch is a material that is used to protect the soil and inhibit weed growth by covering the ground. Good mulches include wood chips, leaves, grass clippings and compost. They can benefit the lawn and garden by preventing erosion, suppressing weeds, retaining soil moisture, moderating soil temperature and adding nutrients as they break down slowly.

- Create a self-mulching lawn. Wait to mow until the grass is between 2 and 4 inches high. Then mow off only the top one-third of the grass and do not bag the clippings. This way, the clippings will feed the soil and not smother the grass.
- Put a 3- to 4-inch layer of mulch around your trees, shrubs and garden plants. To prevent diseases and pest infestation, mulch should not be piled up against the stems or trunks of plants. For best results, use long-lasting mulches (wood chips, wood shavings, evergreen needles, etc.).
- Mulch all areas that are not covered in grass or thick ground cover.
- Use a layer of coarse mulch 3 inches or more in depth for weed control.
- When converting grassy areas to mulch, smother the grass with a thick layer of cardboard or newspaper rather than killing it with chemicals. Some hardy grasses must be rooted out for successful removal.



Marketing and Advertising Analytics

RFPS

The number of RFPs received in November decreased slightly this past month to **95 RFPs** (above average) and **32,653 associated room nights** (below average), which is expected as we head into the holiday season. Year-over-year November 2018 performed better than November 2017 with an increase of 22 RFPs and 5,778 associated room nights.







Website Traffic

Website traffic also decreased in November with **25,126 total sessions** and **24,068 total users** visiting both websites. The Visit Irving website had 18,287 sessions and 17,546 users (below average) while the Irving Convention Center had 6,839 sessions and 6,522 users (below average). Year-over-year performance showed an increase in both sessions and users to the Visit Irving website, while the Convention Center website saw a decrease in sessions and users from November 2017 to November 2018.


Blog traffic in November had **1,775 pageviews** and **1,561 unique pageviews**. The average time visitors spent on the blog was three minutes and 16 seconds (above average) and the bounce rate was low at 23.67%. The top two blog posts were "5 Brunch Spots in Irving You Need to Try this Sunday," with 226 pageviews and "We Tried the 3-Day Juice Cleanse at Freshii – Here's What Happened," with 189 pageviews.





Advertising and Paid Search

Advertising engagement saw **1,858 advertising impressions** and **416 site visits**. MPI was the top performer in November with 656 impressions and 113 site visits, followed by Naylor with 174 impressions and AJR Media with 118 impressions. The Google AdWords paid search campaign had **38,763 impressions** and **5,042 site visits** in November, which generated **13 RFP submissions**.






Hotel and Flight Bookings

Information available through the ADARA Magellan travel intelligence platform displays approximately 70% of the hotel bookings, room nights, hotel booking revenue and flights booked by travelers who viewed the bureau's digital advertising or visited either website. The attribution window is 60 days, which means that the most complete information available to date is from September 2018. In September, 114 hotel reservations were booked, which accounts for 290 room nights and \$35,295 in hotel revenue. Travelers also booked 363 flights in September.



Social Media

Social media in November increased by **576 new followers** and total influence is now at **84,057**. The Visit Irving Facebook Page saw the largest increase with 590 news likes for a total of 54,849 likes.

Texas Passion and Pride

Welcomes All to Enjoy This Bigger-Than-Life Destination By Cynthia Dial

Well-known for its passion and its pride, the vast state of Texas is no stranger to visitors, who are always shown a good time, made to feel at home and are forever welcome by a Texas-size hospitality that envelops all. It's this and more that warmly beckons meeting planners and explains their repeated returns to this bigger-than-life destination.

One such planner is Martha C. Barton, CEM, exhibitor services director, Turbomachinery Laboratory with Texas A&M Engineering Experiment Station (TEES), who has taken the annual Turbomachinery & Pump Symposia to Houston each September for more than 15 years. "The Turbomachinery Laboratory conducts basic and applied research into important problems of reliability and performance of turbomachinery — rotating machinery that extracts or adds energy to fluids," she says about the association. "That's everything from classic Dutch windmills to the space shuttle's main engine turbo pumps and compressors that move natural gas through the distribution system."

Barton explains that though the meetings' objectives are measured in multiple ways, of particular importance are the responses of its participants (from delegates and exhibitors to speakers and authors) and its continued growth, having expanded from 3,000 to 5,500 attendees over the years. The planner says, "Even when the economy was down, we continued to have record-breaking years, which we did again during this year's symposia."

Explaining her destination pick, Barton says, "Houston has a very strong base for oil and gas, energy and technology companies — our target groups. The city ranks in the top five of the nation's Fortune 500 companies — companies from which we have many participants, so it makes good business sense to go where the bulk of your attendees are employed," she says. "Another reason is that we, our event and our attendees are so appreciated. The Houston team is the best; it's a vital part of our success."

Quality Customer Service

Having selected the **Hilton Americas-Houston** and **Hyatt Regency Houston** for her group, Barton expounds on this duo. "The Hyatt Regency was the headquarter hotel for more than 15 years, although we moved it to the Hilton Americas when this property was built due to its proximity to the convention center and to the team whose dedication makes my life as a meeting planner easy," she says. "To this day, we maintain a block of rooms at the Hyatt for their long-term quality customer service and loyalty to us for many years."

Among Symposia attendees' faves are its food and attractions — from Texas barbecue to attending sporting events (perhaps enjoying a Houston Astros game and other events at the Toyota Center).

With 1,200 rooms, a location within walking distance of the convention center, Discovery Green park and a complimentary shuttle for attractions within a three-mile radius, the AAA Four Diamond Hilton Americas-Houston offers 24 stories of appeal to meeting planners. Hyatt Regency Houston is an iconic hotel with more than 71,000 square feet of meeting space and a signature restaurant, Spindletop, that towers 34 floors above the city and offers American seafood with a local Southwest flair and a 360-degree view from this revolving dining room.

"New private development and significant public projects are ... leading to incredible new venues and amenities for visiting groups. Pair all of this with San Antonio's unique sense of place, culture and history, and you have an unbeatable meetings destination." — Casandra Matej

Another option, **Marriott Marquis**, has claim to the city's largest ballroom (almost 40,000 square feet), 100,000 square feet of meeting and event space, Xochi (a restaurant operated by four-time James Beard Award runner-up Chef Hugo Ortego), an infinity pool and whirlpool overlooking Discovery Green and an assortment of outdoor seating areas with fire pits.

The Texas A&M planner gives accolades to the Greater Houston Convention & Visitors Bureau (GHCVB), the George R. Brown Convention Center (GRBCC) and to the city itself.

"Working with the GHCVB, as well as the GRBCC, is an absolute pleasure. The staffs are professional, reliable and kind. You are received as an important part of their lives and leave feeling you are part of a warm and caring team," Barton says.

An appealing bonus is that the downtown Houston area has thrived since the addition of hotels, restaurants, Discovery Green and an improved transportation system. Among Texas' largest city's most distinctive group opportunities are its food and beverage offerings; unique entertainment venues such as Goodnight Charlie's, described as "a honky-tonk with a modern twist;" and events incorporating its three sporting venues and six professional sports teams: Houston Astros (MLB), Houston Rockets (NBA), Houston Texans (NFL), Houston Dynamo (MLS), Houston SaberCats (MLR) and Houston Dash (NWSL).

Its hotel scene is equally impressive. **Magnolia Hotel Houston** is known for its complimentary milk and cookies every evening. The virtual Topgolf swing simulator at **Four Seasons Hotel Houston** gives guests the opportunity to play such notable courses as St. Andrew's and Pebble Beach. Pillow fights can be arranged at **Hotel Derek**, and the best place to cool off from the state's notorious summer heat can be found in the world's only Texas-shaped lazy river at the **Marriott Marquis Houston** (at 6,500 square feet, it takes 15 minutes to circumnavigate). Lastly, **The St. Regis Houston** promises: "No request is too small or unattainable no matter what the hour of the day."

Midway between the east and west coasts, Irving, Texas, is perfectly positioned for the nation's planners. A new headquarter hotel and a vibrant visitors' district are complemented by a top-of-the-line convention center, situated within walking distance of the two.

"Since its opening in 2017, the Toyota Music Factory has become a high-energy site, full of activity — people, music, entertainment, restaurants and retail," says Maura Allen Gast, executive director of the Irving Convention and Visitors Bureau. "For planners, the new complex in the heart of Las Colinas provides a wide range of entertainment and dining options to fill free nights on the convention schedule, and it's an excellent venue for opening or closing night events."

Distinctive Visitor's District

The Live Nation Pavilion amphitheater anchors the new \$173 million Toyota Music Factory complex, which serves up the Alamo Drafthouse movie theater and more than 20 bars and restaurants.

"The final piece of Irving's visitor district, the **Westin Irving Convention Center at Las Colinas** hotel, will open in January 2019," says Gast. Offering 350 rooms and 16,000 square feet of meeting place, including a 10,000-square-foot ballroom, the 12-story hotel is a welcome addition to the Texas city's more than 12,000 guest rooms.

Gast concludes, "Irving's vision for a distinctive visitor's district in the Las Colinas Urban Center will become not only a spectacular reality but a real game-changer for us."

"Eighteen years ago, we chose Irving's **Four Seasons Resort and Club Dallas at Las Colinas** as the site for our resident program," says Jami Lucas, executive director and CEO of the American Academy of Otolaryngic Allergy Association (AAOA) — a Virginia-based national medical specialty society of ENTs and related health care providers who focus on allergy, sinus, asthma, rhinology and related ear, nose and throat diseases, which supports its physician members through advocacy, education and research.

She explains that while this program has evolved over the years, the AAOA's choice in sites has stayed constant for the group which conducts four annual meetings. These include the Interactive Allergy & Rhinology Course (February), the Basic Course in Allergy & Immunology (July), the Advanced Course in Allergy & Immunology (December) and the Annual Meeting (Fall).

It's all about geography. "The location in the middle of the country and resort's 15-minute proximity to the two local airports, Dallas Love Field and Dallas/Fort Worth International Airport (DFW), makes getting to our meetings easy and affordable for attendees," says Lucas. And the climate is ideal for the February meeting. With respect to affordability, the AAOA exec says, "The Four Seasons in Las Colinas offers great value for the money as the ROI, so to speak, is there and continues to be there. Above all, the hotel consistently delivers excellent service."

Situated upon 400 acres between Dallas and Fort Worth, this 405-room, AAA Five Diamond Four Seasons property has such meeting stats as 31 multipurpose rooms, 40,871 square feet of meeting space, including a 7,992-square-foot ballroom and 10,473 square feet of outdoor meeting space — earning the luxury resort such honors as "Best Recently Renovated Venue," by the Best of Texas Meetings + Events 2016 Awards and "Best Golf Resort" by the Best of Texas Meetings + Events 2016 and 2018 Awards.

Regarding specifics, Lucas describes an Interactive Allergy & Rhinology Course meeting's welcome reception last year. Held in Byron's, one of the hotel's eateries, it offered expansive views from its floor-to-ceiling windows of the TPC Four Seasons Las Colinas golf course and showcased local foods and beverages with the inclusion of margaritas, a taqueria and an assortment of Hill Country buffet stations.

For larger groups, Big D has a Texas-size option, the 2 million-square-foot Kay Bailey Hutchison Convention Center Dallas — 1,000,000 square feet of exhibit space, 65,000 square feet of ballrooms (divisible into four separate rooms), 88 meeting rooms and 4,000 hotel rooms within walking distance — all within 30 minutes of DFW airport.

As manager of membership and operations for the Texas Association of Freestanding Emergency Centers (TAFEC), Lisa Keltner explains that her trade association comprises freestanding emergency center owners, both independently owned and hospital-based. She says, "This is a fairly new market, so it's a hotbed in politics and the health care industry, in general."

Thus, what better city to conduct an event of an association with political elements than in Texas' capital city, Austin? Keltner explains, "Austin is a thriving community that is very diverse. We are a high-tech, creative, political and entrepreneurial city with excellent colleges and universities. People are drawn to Austin's 'weirdness;' thus, the theme 'Keep Austin Weird.' I'm a native Austinite, so I get this."

Having conducted her organization's membership meeting at **Hyatt Regency Austin**, located on Lady Bird Lake, this homegrown Texas planner details why the hotel was a match for her meeting of approximately 100 members and sponsors.

"I love the Hyatt Regency Austin because of the space, the staff and the location. Who wouldn't love the Hyatt on Austin's Lady Bird Lake? The fact that they've expanded their meeting space and added a nice and reasonable parking garage also makes it attractive to attendees because parking in downtown Austin is a nightmare and very costly. But we loved every minute of our membership meeting, which offered the best service ever, as well."

Perks for the Planner

With 448 rooms and 45,000 square feet of customizable function space (new Zilker Ballroom's 14,138 square feet of space and an openair 3,700-square-foot terrace), the hotel's location offers additional nearby perks for the planner — from the South Congress (SOCO) shops and dining district, the Warehouse Restaurant District, 2nd Street Shopping District and 6th Street Entertainment District to the State Capitol building, LBJ Presidential Library and The University of Texas at Austin campus. Nature enthusiasts will enjoy the Lady Bird Johnson Wildflower Center and a bat colony visible at the Congress Avenue Bridge.

The planner illuminates the leisure endeavors of the association, which typically spends 90 percent of its time on property. "Generally, we have a reception with live music or some other fun activity such as a sporting event. We've done riverboat cruises, gone to trendy restaurants and learned how to roll cigars, among other activities."

Activities which the planner considers "exclusively Austin" are its riverboat cruise featuring live music and a full bar and the YETI flagship store (an Austin-based company of outdoor products which opened next to the Hyatt Regency), described as "equal parts bar, showroom and a live music venue located on South Congress."

Omni Barton Creek Resort is seeing the results of a \$150 million project — a newly added resort tower with 180 guest rooms, conference center and ballroom, 5,556-square-foot pavilion, six dining outlets, Mokora Spa, lobby experience, expanded poolscape, golf clubhouse, golf course renovations and tennis complex — all set to open in 2019. Also on the horizon is Hotel ZaZa Austin, with 8,500 square feet of meeting and event space.

Keltner gives colleagues insight regarding Austin and its selection as a meeting destination: "I highly recommend Austin for its natural beauty, choices in bars and restaurants, live music and a general laid-back vibe. Most of our members across the state prefer events in Austin to other events we have across the state because everyone just loves coming here!"

Moving a bit south, meet San Antonio. A cultural combo representing Mexico, Germany and Old West roots, it's the notable home to Texas' most visited site — the Alamo. Offering planners the state's most historic legacies, including the nation's oldest operating cathedral (San Fernando Cathedral near the Alamo) and Texas' first UNESCO World Heritage Site (the city's collection of five missions), even San Antonio's culinary landscape is one-of-a-kind — from white tablecloth European restaurants and genuine steakhouses to Tex-Mex eateries, BBQ joints and savory food trucks. Last year, the city was recognized as a UNESCO Creative City of Gastronomy for its unique culinary heritage.


"San Antonio is investing in itself in every direction," says Casandra Matej, president and CEO, Visit San Antonio. "In 2016, we saw the game-changing renovation and expansion of the now-1.6 million-square-foot Henry B. Gonzalez Convention Center (including Texas' largest ballroom at 54,000 square feet). This was followed by major improvements to the Alamodome, completed in advance of the 2018 NCAA Men's Final Four."

Among the town's biggest news is the all-new electric fleet of its iconic River Walk barges. Boat operator Go Rio Cruises offers group opportunities such as brunch and cocktail cruises, even out-of-the-box activities like yoga and spinning can be accommodated — all while enjoying the city from its through-the-town river.

San Antonio offers nearly 45,000 guest rooms, with close to 14,000 located downtown and 6,500 within walking distance of the convention center.

"We've seen multiple new hotels open around the city and another 500 rooms are in the early planning and construction phases downtown," says Matej. "New private development and significant public projects, such as San Pedro Creek, Confluence Park and the redevelopment of Hemisfair, are transforming San Antonio's urban core and leading to incredible new venues and amenities for visiting groups. Pair all of this with San Antonio's unique sense of place, culture and history, and you have an unbeatable meetings destination." **AC&F**

The Mexican avocado is so cool it has its own marketing firm. No, really! Avocados from Mexico (AFM) has been marketing the quirky, creamy, buttery, green fruit since 2013. Michoacán, Mexico, also called the "Avocado Belt of the Mexican Republic" has rich volcanic soil and prime weather conditions. Michoacán is the only place on earth where each avocado tree can get up to 4 blooms. The trees continually yield fruit and each tree can produce up to 750 lbs. per year.

The avocado from Mexico is special. While AFM promotes the amazing fruit, it is important to know that they are not involved in sales, pricing or distribution. Americans love their avocados and are willing to pay \$2.00 extra to have them added on to their dishes, but there still is the perception that avocados are hard to work with. With the right tools, it is easy to remove the pit- you need butter spreader and teardrop tool and voila!

Here are some tips:

How to increase longevity: Olive oil, believe it or not will protect your sliced avocado from oxidation. Other anti-oxidation liquids that can be used include orange juice, lemon juice, pineapple juice, and vinegar. Make sure you place the sliced avocado between two sheets of parchment paper or plastic wrap. How to halt the ripening process: Place the avocado in the fridge. Will McKesson's departure trigger a stampede from California?

McKesson's decision last week to <u>move its headquarters</u> from San Francisco to North Texas raises the prospect that more companies could decide it's time to move to lower-cost, lower-tax cities.

It's especially true for the long list of Bay Area corporate stalwarts outside the tech sector that don't depend on tapping the region's deep bench of tech talent. Then again, even San Ramon-based software maker rfXcel, which plans to eventually employ 200 people, said last week that it's uprooting its East Bay headquarters and heading to Reno, Nev.

"Your employees are your assets and those assets walk out the door every day. If you're not in a region that offers great quality of life, they're not gonna stay," rfXcel CEO <u>Glenn Abood</u> told <u>the Reno Gazette</u> <u>Journal</u>.

In August, Core-Mark Holding Co. Inc. (NASDAQ: CORE) said it will move its headquarters to Dallas-Fort Worth in 2019. The Fortune 500 company is the second-largest distributor to the nation's convenience stores, with 100 of its 9,000 employees working at the corporate headquarters.

"While San Francisco is our long-time home, the business has expanded dramatically over the years,"

said <u>Scott McPherson</u>, president and CEO of Core-Mark. "Being closer to our customers and more central to our divisions will create cost and logistical efficiency for us."

Privately held Bechtel Corp. also moved its long-time San Francisco headquarters to Reston, Va. this year.

Some expect the corporate relocations out of the Bay Area to escalate in 2019 as the region's senior executives find themselves paying higher taxes following Trump's tax overhaul that limits the federal tax deduction for state and local taxes to just \$10,000. Talk of a Bay Area exodus is expected to intensify next spring as the region's residents pay their 2018 taxes.

Perhaps it's an only-in-San Francisco moment that the loss of two Fortune 500 headquarters, plus Bechtel's, creates barely a ripple in the region's business community.

But some are watching warily.

"California has to be responsible in terms of how it thinks about its competitive position. You get in a position where things are going so well you forget that you're in competition," Bay Area Council CEO Jim Wunderman told the San Francisco Business Times in an October interview. "You have to fight to keep your advantage — and taxing, taxing and taxing doesn't seem to me to be the way to do it."

Southern states are becoming more savvy in pursuing corporate headquarters, especially those located in high-tax states such as California. North Carolina is offering larger incentives to win the high-paying jobs that come with a headquarters relocation, which Honeywell (NYSE: HON) <u>cited as one factor</u> in its decision last week to move its home base to Charlotte from New Jersey.

If you count industrial and residential, there are currently more than 600 active sites around North Texas available for development, though they vary in stages of readiness. Here are some of the notable sites available for housing sizable corporate campuses around North Texas:

Other states, especially Texas, aren't shy in going after the headquarters of major companies.

Irving, which includes Las Colinas, where McKesson will move its headquarters in April, likes to call itself the "headquarters of headquarters," with Exxon Mobil (NYSE: XON) and Kimberly-Clark (NYSE: KMB) calling the city home.

In 2016, McKesson (NYSE: MCK) received \$9.75 million in Texas state incentives and \$2 million in incentives from Irving as part of a big expansion there at the time. No additional state incentives were given for McKesson's headquarters move, a spokesman for the Texas governor's office told <u>the Dallas</u> <u>Business Journal</u>.

Irving is courting other companies to follow McKesson, with another 80 prospects for corporate expansions or relocations in the city's pipeline, said <u>Beth Bowman</u>, president and CEO of the Irving Economic Development Partnership.

Then there's nearby Plano, where its ambitions to be the hometown of more companies is apparent from the city naming one of its main drags, Headquarters Drive. The street already features the headquarters of Pepsico's (NYSE: PEP) Frito-Lay division, FedEx (NYSE: FDX) Office, Toyota's North American headquarters, and J.C. Penney (NYSE: JCP).

"If you know of any Bay Area companies wanting to move their headquarters, let them know I'm eager to talk," said Plano Mayor <u>Harry LaRosiliere</u>.

We were as happy as anyone that Frisco landed another big sports headquarters. The PGA of America will be most welcome in our region, and we look forward to many years of great golf ahead.

But it wasn't news without some concern. Our minds turned immediately south, to the fancy new golf course that Dallas City Hall built atop an old dump in the Trinity Forest to host the AT&T Byron Nelson.

Would the PGA of America's new championship course steal the Nelson from Trinity Forest Golf Club in southern Dallas and take it to Frisco, where a 600-acre, mixeduse development, inevitably luxurious, would surround tournament attendees?

Given the lack of similar development around Trinity Forest, it didn't seem like a distant worry. And if that came to pass, what would come of the city's massive investment in the course — money intended to seed opportunity for all of southern Dallas?

For now, we are hopeful that Trinity Forest is secure, at least in the near term. And if all goes well, it's possible that instead of cannibalizing Trinity Forest, the PGA of America may boost it.

First, the PGA's presence in Frisco, fueled by more than \$520 million in a privatepublic partnership, will increase golf's profile in North Texas. That's good for everyone.
