Chair Clem Lear called the meeting to order at 11:45 a.m.

Cecilia Castillo from the City Secretary's Office lead the swearing in of newly appointed Board Chair Clem Lear and Board Vice Chair Ron Mathai and renewing Board members Karen Cooperstein, Debbi Haacke, Rick Lindsey, and Joe Marshall, and newly appointed Board members Bob Bourgeois and Julia Kang.

Lear asked for a motion to accept the Consent Agenda as presented. Board Member Rick Lindsey made a motion to accept; second by Board Member Debbi Haacke. With no opposition and no further discussion, the Consent Agenda was unanimously accepted as presented.

After review, Lear asked for a motion to approve the Budget Adjustment Transfer of \$315,249 achieved from Convention Center FY 2016-17 operational savings to the Convention Center Reserve/Capital Projects Fund. Lindsey made a motion to approve; second by Board Member Greg Malcolm. With no opposition and no further discussion, the budget adjustment transfer was unanimously approved as presented.

REPORTS:

BOARD CHAIR - EXECUTIVE COMMITTEE

In recognition of Teddie Story's leadership for Irving Cares, Story was presented with a plaque from the Board with expression of gratitude and appreciation. Lear commented that she met Story 27 years ago when she was the Director of Volunteers for Irving Cares. Gast thanked Story for decades of service in the Irving community. Lear acknowledged Councilman Kyle Taylor and congratulated him on his appointment as the new CEO of Irving Cares.

Lear noted the Board meeting and schedule included in the packet and asked Board members to add the dates to their calendars. Committee meeting updates and schedule will be completed and distributed at an upcoming Board meeting. A Committee sign-up sheet was distributed as a handout and Lear asked Board members to complete and return the form. She noted the Industry Hospitality Annual meeting on January 22, 2018 will be in place of the January Board meeting. The Executive Committee will meet as scheduled on Friday, January 19 and she encouraged everyone to attend. A non-mandatory meeting on January 4 for Board members will be a tour of the Big Beat Dallas venues at the Toyota Music Factory with a light lunch included. Those interested in attending the tour were encouraged to RSVP to Executive Director Maura Gast.

BOARD DEVELOPMENT COMMITTEE

Lear reported a new Committee Chair and Vice Chair of the Committee will be announced at a later date.

COMMUNITY RELATIONS COMMITTEE

Committee Chair Rick Lindsey extended his congratulations to Gast and team for an outstanding and successful ICVB 45th Anniversary celebration. The event was well attended and he thanked Mayor Stopfer and City Council members for attending. He reported the Committee met on December 15 and approved the High Spirited Citizen nominations that were brought forward for approval and thanked the Board for their support. He added the next High Spirited Citizen presentation at City Council will be in February for Robert and Jill Martinez. He asked all Board members to attend. He reported the Committee also discussed a proclamation for National Travel and Tourism Week.

DESTINATION DEVELOPMENT COMMITTEE

Committee Chair Greg Malcolm reported the Committee met and discussed the Drive Nation athletic facility, had an update on the Dallas Rugby Club proposal and discussed the Hotel Engagement Survey. He noted among future agenda items will be security measures at the Irving Convention Center.

CITY REPORTS:

Councilman John Danish reviewed some major milestones in 2017 and noted it is important to remember as a wrapup to a successful year that things happen due to a philosophy that prevails in relationships and partnerships. Elections matter and are how philosophies develop in politics. He said he is sure 2018 will be another prosperous year for Irving and he wished everyone a happy holiday season and new year.

Councilman Oscar Ward added his good wishes to the Board and staff for a happy holiday and prosperous 2018. He reported as Chair of the City's Audit and Finance Committee the audit process has started, and Irving is one of the few cities that finishes their audit before the end of January. He noted it is imported to maintain the AAA Bond rating and he is looking forward to the auditor's report.

Councilman Kyle Taylor shared his wishes for a happy holiday season and he is looking forward to 2018. He expressed his appreciation for the hard work, time and energy it takes to make the City of Irving what it is.

City Manager Chris Hillman congratulated the CVB on 45 great years and noted a lot has changed in those years. He echoed Danish's remarks in taking time to reflect and look back to see what has been accomplished. He gave a brief review of the year that included new business openings, economic developments, City projects, the Toyota Music Factory and Convention Center Westin Hotel project. He expressed his thanks and appreciation for all who participated in the Hurricane Harvey shelter effort. He also reviewed awards and recognitions Irving has received in 2017. It was an incredible year and he is looking forward to 2018. He thanked everyone for helping to make Irving a success.

Mayor Rick Stopfer reported City Council, City staff, Irving-Las Colinas Chamber and Irving CVB will meet during the first part of 2018 to determine what is required to do business in the City of Irving and have a plan in place for staff to do their job. He reviewed a few highlights from 2017 for the City. He added the TIF has made the Urban Center what it is today and kept the City in the forefront with great results. He expressed his heartfelt thanks to the CVB for all their efforts over the years and commitment to the City. He added it is because there is a strong CVB that the city has museums, the Arts Center, and hotels and now adding the Convention Center hotel. He noted that because of the efforts for arts programs, advertising and marketing the city and spreading the message, things are moving forward for Irving. He reported the high-speed rail project passed and is moving forward, which will add another dynamic to the City and metroplex area. He wished everyone a great holiday season and new year.

Lear asked Stopfer to update on DFW Airport runway construction. Stopfer replied DFW has seven runways, but one will be shut down for a period of time during the facelift in 2018. Work will begin mid-2018 and should take approximately four months. Flights will use the airport's other runways and are not expected to encounter delays due to the construction. He added the duty-free facility in Terminal D is set to open and will give travelers a luxury shopping experience in a two-story store between gates D22 and D23.

STAFF:

Assistant Executive Director/Sales and Services Lori Fojtasek reported it has been a very busy last few months in 2017. The sales team has a record number of site inspection tours scheduled for Irving and the developments in the area have added to the interest. People are interested in the Toyota Music Factory, the Convention Center Westin hotel and the Texican hotel. She reported sales has booked the first group for the Convention Center Westin hotel for March 2020, with a group of 800 room nights and 350 rooms on peak. The sales team has been bidding on this convention since 2005. Sales is co-hosting an event in March with the Four Seasons for Prestige Global Meeting Source national sales meeting. She reported being excited to showcase the City of Irving.

Assistant Executive Director Diana Pfaff reported the new irvingtexas.com website had a soft launch in November with a complete new design. The new website will reflect the CVB's new leisure travel marketing strategy and the launch of the new site has been timed to roll-out with the opening of the Music Factory. Pfaff reported the CVB has a new logo design and will debut on January 22, 2018 at the Industry Hospitality Annual meeting. She reported the Communications team hosted a national press tour for six journalists that has had great coverage already. Pfaff pointed out the last page of the Marketing Communications report that was distributed as a handout that lists the 2018 Spirit of Irving Award recipients: The Carpenter Award – McKesson; The Nelson Award – Drive Nation; The Townsell Award – J.C., Gonzales, Irving Hispanic Chamber of Commerce; and The Martin Award – Beth Salemme, LAW – Four Seasons Resort and Club. The awards will be presented at the Annual meeting.

Assistant Executive Director/Finance and Administration Mike Zumbaugh reported the November STR data has not been received and he will review November and December data at the February 26 Board meeting.

CONVENTION CENTER:

General Manager Tom Meehan reported the ICC is off to a great start for the fiscal year. Projections for the year are to exceed last year, which was a very profitable year. To date, the ICC is 16 events above pace from last year. Staff has signed a number of contracts over the past few weeks. The Jehovah Witness group has re-signed a contract for 3,000 guest room nights. The Hilti annual meeting re-signed a contract for 1,500 room nights. Meehan announced Onex has acquired SMG from Northlane Capital Partners. Onex is a leading investment firm in North America with a long history of successful building industry-leading businesses. He stated that it is "business as usual" for clients, and no corporate changes are expected.

Lear added the ICC calendar of events is included in the meeting packet each month. Gast noted that any event that is open to the public will be on the ICC website, but 95% of events are company and/or private events. The calendar in the meeting packet specifics public events with an asterisk notation (*).

INDUSTRY REPORTS:

HOTELS AND RESTAURANTS

Board Member Greg Malcolm reported for the first part of December, South Irving had a very strong month, up 3.6% in Occupancy at 79%, Average Rate was \$135.92, and RevPAR is up 10.5% at \$107.40.

Lear congratulated Board member Kim Limon, General Manager of the Hampton Inn Las Colinas, who was recognized with the prestigious 2017 GM of the Year award during The Hotel Association's Annual Gala Awards Extravaganza. Limon reported December was a busy month for the Hampton Inn Las Colinas, and is projecting to be above budget by approximately \$10,000.

DART

Mayor Stopfer gave an update on DART, and reported final work on the Cotton Belt project will hopefully start in the next six months along with the D2 alignment. The D2 project is the future second DART light alignment through downtown Dallas. Expected discussions at the January 5 DART Retreat will be fare increases, security and safety and ridership. The goal is to have a security officer on every train and 50% of buses. The homeless community continues to be a challenge. Fare increases will be a challenge as cost of operations and labor go up, but to stay competitive it is necessary to charge what it takes to operate efficiently and effectively. He noted the DART Board is in place and no new members will be added, and the focus is on how to make things better. Stopfer added the road construction in Irving is painful, focus is on the Texas Stadium site and bridge. It is important to try and have as much of the ground ready and up to speed as the market continues to review that area.

TIF

Board member Mark Cronenwett reported the next TIF meeting agenda will include Convention Center Westin hotel update, renovations at Williams Square and the TIF extension. He noted the City has done well by TIF with the foresight to put it together and it has been the most successful in Texas. The TIF funds infrastructure and needs throughout the City.

UNIVERSITY OF DALLAS

Board member Bob Galecke reported progress on the new student and administrative building, which is expected to open in early 2018. The dedication is expected on February 2, 2018 at 3:30 p.m. The Cardinal Farrell Hall will honor Cardinal Kevin J. Farrell, who previously served as bishop of the Catholic Diocese of Dallas. He is expected to continue his relationship with the university as one of the trustees. The building will replace the original Carpenter Hall from 1956. The new building is LEED-certified. He reported UD sold 28 acres of land to Meritage Homes on Northgate Drive. The project has 92 single family homes and models are being built. UD sold a 265-unit off-campus apartment building to an investor group in California and closed the deal in August. Enrollment in college is at an all-time high and Galecke stated he is happy to be part of the community.

GREATER IRVING-LAS COLINAS CHAMBER OF COMMERCE

Former Chamber Chair Rodney Phelps attending for newly appointed Chair Lori Bunger and congratulated the CVB for celebrating 45 years of delivering hospitality excellence. He reported 2018 is off to a great start with five project wins, bringing more than 1,200 jobs to Irving since October 1. There are 49 projects in the pipeline and still awaiting response from the Amazon HQ2 project. As of October 2017, Irving's unemployment rate is 2.9%, which compares favorably to Texas at 3.95% and the national rate of 4.1%. Chamber President Beth Bowman reported the Chamber's Board of Directors had their annual retreat where they laid the groundwork for a new strategic plan for the upcoming years. She thanked Lear and Gast for attending and actively participating. She reminded the Board the State of the City will be on January 16, at the Irving Convention Center. John McCaa from Channel 8 WFAA, who is an Irving resident, will moderate a conversation with Mayor Stopfer.

CULTURAL AFFAIRS

Executive Director Todd Hawkins congratulated Gast and the CVB team for 45 years of success and a wonderful celebration event. Hawkins reported the Main Gallery at the Arts Center has 15 decorated Christmas trees by local arts agencies in the area. January is a full month of activities, including Kraig Parker as "Elvis" on January 6, Gazebo on January 19, the Las Colinas Symphony concert on January 20 and Travis Tritt will perform on January 27. The notorious all-male drag ballet company, commonly known to audiences around the world as the "Trocks," will perform on January 30 in Carpenter Hall. 'This Light of Ours: Activist Photographers of the Civil Rights Movement' opens on January 13 and runs through March 4. This is a major traveling exhibition and features 157 black and white photographs.

Lear thanked everyone for the honor of leading the Board as Chair and wished all a happy holiday season and new year.

With no further business or comments, the meeting was adjourned by Lear at 1:02 p.m.








RFPS

January was an exceptional month with a total of **121 RFPs** (well above average) and **26,953 associated room nights** (above average), which was the highest number of RFPs to date. Of those, three RFPs came from the telemarketing program through Strategic Database Research that launched in December.



Website Traffic

Website traffic increased dramatically in January with **34,473** total website visits and **33,390** unique visitors to both sites. The irvingtexas.com site had the second highest number of visitors to date with **19,100** unique visitors (well above average). This was the highest number of website visitors to irvingtexas.com since October 2014. The Irving Convention Center website had three times the number of visits as the previous month with **14,290** unique visitors. This was second highest number of visitors to this site in the past two years. Website engagement for irvingtexas.com continues to show improvement since the site relaunched, with the overall bounce rate continuing to trend downwards, while the average number of pages per session remains high.



Advertising


The bureau's advertising in trade publications, which includes both print and digital, also had the highest numbers to date, generating **2,581 website visits**. MPI was the top performer with **670 click throughs** followed by *Meetings Today* and TripAdvisor, both with **254 click throughs**, and AJR Media with **230 click throughs**.

The ICVB's ad campaign with Fast Company magazine continued with its fourth Irving-specific wrapped issue. A thousand (1,000) meeting planners throughout the country selected to get a year's worth of wrapped publications have received the Feb 2018 issue, "Suite Success," which focuses on Irving's vast hotel community, while also highlighting meeting spaces, event venues and off-site amenities such as dining and entertainment.



The bureau's Google AdWords had the highest response to date with **10,050 click throughs** to the irvingtexas.com and irvingconventioncenter.com websites along with **13 RFP submissions**. Typically, the bureau averages around **2,000** click throughs per month from Google AdWords. The bureau recently launched new campaigns to target the leisure market and the Live Music Campaign generated **39,806 impressions** and **6,564 click throughs** in January.

The retargeting campaign through Multiview, which retargets meeting planners who visited MPI's website, also performed well with **330 click throughs.**







Hotel and Flight Bookings

Information available through the ADARA Magellan travel intelligence platform indicates that January performed well again and was the third highest month since the bureau began tracking this data in May. Estimates show that approximately **236 flights** along with **326 room nights** were booked, which accounts for **\$51,041.41 in hotel revenue** for the month.

Marketing Activities

In January, the marketing team launched two key digital content marketing initiatives. Local influencers will now be writing for the Visit Irving blog. Along with staff, these writers will be adding new content, which will drive blog postings to an average of three times per week. The bureau has also launched a new content program with our digital marketing firm, who have recently completed a three-month research and audit of our website performance from trailing twelve months. Based on these findings, they will be providing new content and improving the existing content on irvingtexas.com. Both initiatives are already underway and will continue through the remainder of the year.

The bureau's first visitor/lifestyle magazine was launched at the annual meeting. Named "Surveyor" in honor of Irving founders, the publication will run three times a year with a current circulation of 100,000.

The department also conceptualized and executed creative elements for the annual meeting, including collateral, decorative settings and multimedia.




Three Year Comparison - CITY OF IRVING - ALL PROPERTIES







Annual Year End Figures And YTD through December 2017








Three Year Comparison - Las Colinas December 2017

Dallas Cowboys owner Jerry Jones' real estate company has plans for a new project in Irving

Dallas Cowboys owner Jerry Jones' real estate company is gearing up for a major project in Irving.

The same team that developed the Cowboys' huge Star in Frisco development is working on the mixed-use development in Las Colinas.

The almost 28-acre project is planned at the south corner of State Highways 114 and 161.

Plans filed with Irving's zoning commission say the development will include a hotel, retail space and apartments on the vacant corner.

The development will be built by the Jones family's Blue Star Land LP and Dallas-based Lincoln Property Co.

Lincoln Property was part of the team that built the first phase of the \$1.5 billion Star in Frisco. And Lincoln is developing the Gates of Prosper shopping center with Blue Star on U.S. Highway 380 in Collin County.

Lincoln will build 288 apartments in the Las Colinas development on Meridian Drive east of S.H. 161, according to the plans.

"The Blue Star Land multi-use project is a perfect fit for the residents and workforce that are now flocking to Irving-Las Colinas because of the live, work, play, walk environment that millennials are demanding," said Beth Bowman, president of the Irving Las Colinas Chamber of Commerce.

The hotel and retail site is to the north along High Point Drive.

A community park is planned at the center of the development.

Dallas architect GFF did the site design.

Blue Star land officials did not respond to requests for information about the timing of the project.

Irving's city council still must give final approvals for the development.

Blue Star Land has owned the high-profile Las Colinas property since 2010.

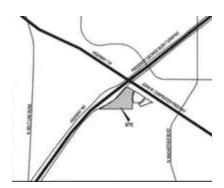
The development is one of several mixed-use projects on the way in Irving.

"In addition to the announced projects like Blue Star that are either underway or planned to kick-off soon, we are pleased to see additional activity for both new residential and commercial development," said J. Hammond Perot, president of the Las Colinas Association. "Given where we are at this stage of the cycle, as well as the amount of developable real estate remaining, it certainly appears that we are in for another good year of activity."

Apartment builder Gables Residential is opening its long-awaited Water Street retail and apartment project on O'Connor Boulevard in Las Colinas.

And developers are finishing up construction on the Toyota Music Factory entertainment, restaurant and retail complex on S.H. 114.

"With the Dallas MSA on the short list for the Amazon HQ2, and the momentum we see in our economic development pipeline, we think this is going to be a very strong year for Irving-Las Colinas and North Texas," Bowman said. "As a dozen new restaurants and entertainment venues come online at the Toyota Music Factory, the opening of Water Street and other projects, we now have the lifestyle amenities that corporations and residents are seeking."



Irving's city council has given Dallas Cowboys owner Jerry Jones' real estate company the go-ahead to build a high-profile mixed-use development in Las Colinas.

The almost 28-acre project will be at the south corner of State Highways 114 and 161, east of Dallas/Fort Worth International Airport.

The Jones family's Blue Star Land LP and Dallas-based Lincoln Property Co. plan to develop a hotel, retail and apartment project on the vacant corner. The project could be worth as much as \$100 million with the addition of adjoining development sites owned by Blue Star Land.

Stars' Tom Gaglardi gets nice deal on Frisco land for upscale Sandman hotel

"We've been working on it for over a year," said Bobby Stewart with Irving-based CSE Commercial Real Estate, which represented Blue Star at Thursday's Irving city council meeting. "We're asking for general site plan approval so we can do a mixed-use development."

He said Blue Star is committed to doing what the "city wants, which is a full-service hotel. It would be at least 200 rooms."



The hotel would be joined by 288 apartments in the Las Colinas development that Lincoln Property will build. There is also a small park area connecting the hotel and retail with the rental community.

The hotel the developers are in discussions with would have a Moxie's Grill & Bar restaurant in the ground floor. Moxie's is a Canadian restaurant chain owned by Dallas Stars hockey team owner Tom Gaglardi. The Vancouver-based restaurant chain has opened locations in Dallas' Crescent complex in Uptown and in Houston.

"The hotel group we are talking to has a full-service restaurant on the bottom of the hotel and one of the restaurants they have a relationship with is [Moxie's]," Stewart said.

Gaglardi also owns the Canada-based Sandman Hotel chain, which is also expanding to North Texas with its first location planned in Frisco.

Irving's city council unanimously approved Blue Star Land project.

Stewart said the two other properties the Jones family owns next door are being reserved for corporate projects. "It will probably be office uses," he said.

Dallas architect GFF designed the development.

Blue Star Land has owned the high-profile Las Colinas property since 2010.

The project is right across the highway from where medical industry giant McKesson Corp. has its huge regional office center with more than 1,000 workers.
