## Jackson County Tourism Development Authority Board of Directors Meeting April 15, 2015

## **MINUTES – PENDING APPROVAL**

Vice Chairman Mary Lanning opened the meeting at 1:04 pm with introductions. A motion was made by Jim Hartbarger to approve the monthly minutes, seconded by Ken Fernandez. The motion passed unanimously.

Darlene Fox then presented the financial statements, stating that the totals are up 26% for the fiscal year to date revenues collected, and discussion followed. A motion was made to approve financials by Alex Bell, seconded by Clifford Meads. The motion passed unanimously.
