


## January 31, 2017

- \* 114 units reported for December rentals. The collections up 41.29% from the same period in 2016. The total increase for the fiscal year is 13.62%.
- \* The cash balance at January 31, 2017 is \$685,245.32
- The expenses for January were \$62,825.80. The YTD expenses totaled \$533,733.58 with encumbrances of \$1,452.49, for a combined total of \$535,186.07 54.56% of budget.

## TDA Expenses as of January 31, 2017






