Minutes: Motion made made Henry Hoche to accept, second by Mary Lanning, approved unanimously.

Financials: Darlene disbursed – see report. Alex made the motion to accept the financial statements as presented by Mrs. Fox, motion seconded by Mary, approved unanimously.

Marketing: Mr. Meads stated he has a meeting planned with the Brandon Agency for the first week of December. Website updates and a general overview of website maintenance, along with planning for 2016 will be discussed.

Pineapple PR: made a presentation to the board, disbursing a proposal for the creation and ongoing production of a blog for the TDA (see hand out). A discussion ensued – Darlene recommended the board discuss the agency contracts no later than February, to align with budget requests for the upcoming year. JCCC – see report, Julie presented a summary of upcoming events, visitor analytics from the Jackson County Visitor Center and Dillsboro Center for the previous month, mini fam involvement, and ongoing projects.

Robert Jumper – reviewed that board received five contractor proposals for the TDA contracted position. He stated the panel interviewed all five candidates, narrowing the field to two (2) finalists. There will be a meeting on Friday November 20 with the two finalists. All three contracted agencies (Pineapple, Brandon, and INNsights) have been invited to take part in the final interview process, along with Rich Price and the Executive Directors of both Chambers. Jumper announced the final two candidates are Jackie Brendle and Nick Breedlove.

Robert Jumper – Commissioners will make a decision in December on vacated TDA seats and TDA Chairperson position. He stated that there will not be a TDA Board meeting in December Guest comments:
