
## JACKSON COUNTY TOURISM DEVELOPMENT AUTHORITY HIGHLIGHTS September 30, 2015



- \* The cash balance at September 30, 2015 is \$558,206.41
- The expenses for September were \$62,602.19. The YTD expenses

  \* totaled \$152,728.09 with encumbrances of \$176,445.00, for a combined total of \$329,173.09 -39.76% of budget.




