

2018 JUNEAU TRAVEL FAIR ALASKA AIRLINES TICKET CONTEST

[Social Media Terms and Conditions; paper entry terms and conditions]

- 1. The promoter is Travel Juneau, whose registered office is at 800 Glacier Ave, Ste 201, Juneau, AK 99801.
- 2. The competition is open to residents of the United States aged 18 years or over. Employees of Travel Juneau, including board members, employees of member businesses participating in the 2018 Juneau Travel Fair, their immediate nuclear family members and anyone otherwise connected with the organization or judging of the competition are prohibited from entering.
- 3. There is no entry fee and no purchase necessary to enter this competition.
- 4. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.

- 6. Travel Juneau will accept entries on the following social media platforms: Facebook, Twitter & Instagram.
- 7. Travel Juneau will accept entries submitted on a paper form at the event.
- 8. Only one entry will be accepted per person on each medium. Multiple entries from the same person on the same social media platform will be disqualified.
- 9. Closing date for entry will be April 15th, 2016 at 4:00 p.m. Alaska Time. After this date, no further entries to the competition will be permitted.
- 10. No responsibility will be accepted for entries not received for whatever reason.
- 11. The rules of the social media competition and how to enter are as follows:
 - a) Entrants must be 18 years or older.
 - b) Entrants must post a photo on the social media platforms noted in section 6.
 - c) Entrants must include the hashtag "#JNUtravelfair" in their post.
 - d) The photos must be taken at the 2018 Juneau Travel Fair between 12:00 p.m. 4:00 p.m. AKDST. Posts that are not located at the event will not be considered.
 - e) Photos posted to Facebook must be made public in the post's privacy settings. Posts not made public on Facebook will not be considered.
- 12. The rules of the paper form competition and how to enter are as follows:
 - a) Entrants must be 18 years or older.
 - b) Entrants must fill out a paper entry form available at the Travel Juneau table and submit it in the marked receptacle at the table. No entries may be submitted after 4PM on April 21st.
 - c) Entrants must include their name, address, and contact information.

The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control.
