This 2025 season it is occurring again with several helicopters returning to their base mid day and evenings. Again, over houses flying at around 300/400 feet estimated. Very loud. In the past they flew down the channel and that meant less noise. We'd appreciate it if you can get them to resume flying the channel route. Thank you.	1 Northstar Helicopters	NORTHSTAR HELICOPTERS TO SUBMITTER: ****, Thanks for this. This is the time of the year I expect to see a few mistakes from our new pilots, however we really haven't gotten much flying in yet due to the weather. I checked with our company instructors and the route is being taught correctly, and you are right our tour helicopters should be mid channel as they are passing the highland area. Couple questions for you. Can you tell if the aircraft that are flying over highland are blue in color? When you state that they are returning "mid-day and in the evenings" this makes me think that the aircraft you may be seeing (or hearing) are a handful of utility helicopters doing work down on the annex power station. The project has been going on for several years now. For our part, NorthStar operates several tours out of the base formerly run by ERA helicopters on North Douglas. When weather allows we always try to use the route that leaves the heliport and almost immediately turns up Salmon Creek and on to the icefield. This is our preferred route and provides for the least amount of noise for the community. However when the ceiling is lower we have to fly down the channel and again you are correct that on the inbound leg our aircraft should be tracking mid channel as they pass the area abeam Highland. They should also be crossing the bridge at 2000' and descending to be at 1000' when abeam the antenna near Salmon Creek. Please feel free to reach out directly to me if you see any blue helicopters overflying Highland Subdivision and if you can provide an exact time of day when it happens that can be very helpful in finding out who and why it occurred. Best regards, Andrew Green, Port Director PRINCESS/HOLLAND AMERICA/SEABOURN TO CALLER: Thank you for your comments and fully understand that fog horns required by USCG, and international safety regulations can be disturbing here and in many other seaports around Alaska and the world. Unfortunately, there is no clearly developed technology that exempt vessels from these regulations, and thus, the safest manner in which to make other vessels aware of your presence when visibility is low is the use of the ship's whistle. Below from TBMP which also comes from USCG: SOUNDS OF A PORT: Included as part of the operating procedures of any large vessel is the need, requirement, and ability to signal other vessels in the area of their position (in areas of restricted visibility) and of their intentions (when under way or getting under way). These signals are required for safe navigation. In addition, many small vessel operators may not have or may not consistently monitor their VHF radios. Therefore, the only way for large vessels to communicate (regardless of visibility issues) is via sound signals. This is a common practice in the maritime industry around the world. The USCG regulations require vessels to use their whistles to signal when they are in an area of restricted visibility, which is defined as "any condition in which visibility is restricted by fog, mist, falling snow, heavy rainstorms, sandstorms, or any other similar causes." The USCG defines a ship's whistle as any sound signaling appliance capable of producing the prescribed blasts and which complies with the specifications in Annex

Instead, they are parking right by the entrance to the trail creating pedestrian congestion ie. a bottleneck at the entrance to the park trail, impeding trail users like myself. Today Last Chance Tours was in the yellow zone which is a ramp so that wheel-chairs can access the trail. I did talk with one driver (Harv N Marv) and asked if he knew about the bus parking; he said yes but he wanted to park closer for his clients. TBMP Best Practices "Agreements Regarding Transportation and Vehicles" section says that "parking for commercial vehicles shall be in designated spaces" p. 8. Note that a lot of public feedback was given at the CBJ commercial permit meeting last year about the problematic congestion at the Brotherhood Bridge trailhead. Please direct buses to designated spots so congestion at trailhead is mitigated. You may want to consider posting "No commercial loading" signs at trailhead.
