PROCEEDINGS OF THE BOARD OF COMMISSIONERS OF THE LAFAYETTE CONVENTION & VISITORS COMMISSION, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD APRIL 11, 2018

The Board of Commissioners of the Lafayette Convention & Visitors Commission, State of Louisiana, met in the Lafayette Convention & Visitors Commission boardroom, 1400 NW Evangeline Thruway, Lafayette, LA at 3:15pm.

In attendance was the board of Commissioners as follows: Chair Susannah Malbreaux, Vice-Chair Summer Hvasta, Treasurer Matt Roth, Jimmy Thackston and Amos Batiste.

Commissioners Williams, O'Meara, Trahan and Schilling were absent due to prior commitments.

CALL TO ORDER

Chair Malbreaux called the meeting to order.

DEPARTMENTAL REPORTS

TOURISM DEPARTMENT

Eugenie Mitchell, Vice-President of Tourism Sales, reported on Travel South Domestic Showcase where Kaylie LeBlanc had 56 pre-scheduled appointments. She also reported on the Travel South Post FAM Operator on March 22 in Lafayette.

Ms. Mitchell reported on her attendance at Active America China in Atlanta where she met with 23 wholesalers and receptive tour operators.

Ms. Mitchell also reported on the Millennium Voyages FAM Tour on March 26 in Lafayette.

Ms. Mitchell gave an update of meetings and functions attended, leads and requested information sent out and upcoming tourism opportunities.

CONVENTION DEPARTMENT

Mike Roebuck, Chief Sales Officer, reported that the Convention Department sent out 18 leads to area hotels in **March** with 4 definite, 7 assists, 28 outside definite and 44 tentative. He reported that the economic impact for the month was 2.27 million dollars. Mr. Roebuck also reported on leads sent out to Cajun BMX, HOGS, York Rite Shriners, Louisiana Attorney General Justice of the Peace and Constables Training, World Clown Association and Senior Softball.

Mr. Roebuck also reported on **March** activities including the quarterly DOS meeting, bids submitted and bids awarded.

COMMUNICATIONS DEPARTMENT

Jesse Guidry, Vice-President of Communications, reported that 10 print and 9 digital ads were placed in the month of **March**. Mr. Guidry reported that www.lafayetteTravel.com had 88,523 site sessions in **March**.

Mr. Guidry reported that the inaugural Vermilion Voyage had 26 participants ranging in ages from 18-68.

MEDIA RELATIONS & SPECIAL PROJECTS

Kelly Strenge, Vice-President of Media Relations & Special Projects, was absent due to her attendance at the Midwest Travel Journalists Association Spring Conference in Milwaukee. Mr. Berthelot presented the Media Relations & Special Projects report on her behalf.

Mr. Berthelot reported that Ms. Strenge assisted Cycle Zydeco with media coverage during the bike tour.

Mr. Berthelot reported that a delegation from Belgium visited Lafayette April 6-7 included three governors and several mayors, for a total of 30 people from sister cities. He reported that the office also gave assistance to a journalist from Namur, who stayed a few extra days.

Mr. Berthelot reported that LCVC will assist with sponsorship for an event on Friday, April 27 during Semaine de la Francophonie.

Mr. Berthelot reported that the Dancehalls Brochure is being updated and the 2nd quarter Communiqué is getting ready to go to print.

Mr. Berthelot reported that LCVC is working with Samantha Brown and her production company to have them film an episode of her new nationally-aired travel show.

Mr. Berthelot reported that \$76,132 of editorial was written on Lafayette in the month of **March** according to the Meltwater report.

MEMBERSHIP DEPARTMENT

Sadie French, Controller, reported that LCVC had 4 new members and 31 renewals for the month of **March** with 441 members.

Ms. French reported that the **April** LCVC Membership Luncheon was held at the Chandelier Room on April 11th with approximately 93 in attendance.
