CALL TO ORDER

Chair Malbreaux called the meeting to order.

MINUTES FROM NOVEMBER 28, 2018

DEPARTMENTAL REPORTS

TOURISM DEPARTMENT

Eugenie Mitchell, Vice-President of Tourism Sales, reported that Hotelbeds Group conducted a familiarization tour of Lafayette on November 1 and 2. She also reported on show results from the World Travel Market in London with 29 trade appointments over 3 days, National Tour Association in Milwaukee with 25 prescheduled appointments, Ontario Motorcoach Association in Windsor, Ontario with 22 appointments and Travel South International in Nashville with 37 appointments.

Ms. Mitchell reported on upcoming marketing opportunities including American Bus Association, NAJ Receptive Tour Operator, Travel South Domestic Showcase, International Tourism Berlin, Heritage Clubs International Peer Group and JAJ active America China.

Ms. Mitchell also reported that the visitor count to the Visitors Center was up from the previous month.

CONVENTION DEPARTMENT

Mike Roebuck, Chief Sales Officer, reported that the Convention Department sent out 8 leads to area hotels in the month of **November**, with 4 major leads coming from the Louisiana Baptist Adult Conference, American Powerboat Association, Zeta Phi Beta and Sugar Bert Boxing. He reported the department had 10 definite bookings.

Mr. Roebuck reported on **November** activities in the department that included the Director of Sales quarterly meeting, site tours with HotelBeds, Louisiana Society of Association Executives Christmas social, attendance at the grand opening of the Tru by Hilton and the Connect Faith Tradeshow.

COMMUNICATIONS DEPARTMENT

Jesse Guidry, Vice-President of Communications, reported that 4 print ads were placed in the month of **November** with 9 ongoing active digital ads. Mr. Guidry reported the metrics from www.lafayetteTravel.com, according to Simpleview, and noted there were 55,362 site sessions in the month of **November**.

Mr. Guidry also reported that according to Meltwater, 58 articles are in currently in circulation about Lafayette and the Acadiana area.

MEMBERSHIP DEPARTMENT

Sadie French, Controller, reported that LCVC had 1 new member and 13 renewals in the month of **November** with 447 members. Ms. French reported the revenue for **November** was \$925.00 and \$21,975.00 for the year-to-date.

Ms. French reported that the **December** Membership social was held on December 12 at Homewood Suites with approximately 25 in attendance.
