Mr. Berthelot reported that he was named to the Executive Committee of LTPA at the annual meeting. He also reported that Charlie Goodson was named Restauranteur of the Year and DoubleTree by Hilton was named Full-Service Hotel of the Year.

Mr. Berthelot reported that he met with Ben Roberts of Home2Suites to discuss revitalization of the Acadiana Hotel and Lodging Association.
