You will be notified of your eligibility within 21 days. Eligible customers will receive instructions on how to use the service.

Para-transit Ride Scheduling: Call the office between 8:00 a.m. and 4:30 p.m. the day prior to your appointment.

Para-transit pick up is from origin to destination.

NOTICE



The Department of Justice published revised final regulations implementing the Americans with Disabilities Act (ADA) for Title II (State and Local government services) and Title III (Public accommodations and Commercial Facilities) 49 C.F.R. Section 37.167 (d) states:

Under this section, “SERVICE ANIMAL” is defined as “any guide dog, signal dog, or other animal individually trained to work or perform tasks for an individual with a disability, including but not limited to, guiding individuals with impaired vision, alerting individuals with impaired hearing to intruders or sounds, providing minimal protection or rescue work, pulling a wheelchair, or fetching dropped items.”

AVISO



El Departamento de Justicia publicó el reglamento final revisado implementando el Acto de Americanos con Desabilidades (ADA) para el Título II (Servicios gubernamentales estatales y locales) y el Título III (Alojamientos públicos e instalaciones comerciales) 49 C.F.R. Sección 37.167 (d) indica::

Bajo esta sección, “ANIMAL DE SERVICIO” es definido como “cualquier perro de guía, perro de señales, o cualquier otro animal que este entrenado individualmente para trabajar o realizar tareas para un individuo con alguna discapacidad, incluyendo pero no limitandose a, guiando a individuales con problemas de vision, alertando a individuales con discapacidad auditiva a un sonido o intruso, proveyendo proteccion minima o trabajo de rescate, traccion de silla de ruedas, o traer objetos caidos.”

3-BAG LIMIT



THERE IS A 3-BAGS LIMIT WHEN RIDING THE CITY BUS.

- You are responsible for loading/controlling/unloading all of your bags yourself.
- The driver is not responsible for loading, controlling, or unloading your bags.
- Bags are not allowed to be stored in the aisles or doorways.
- Bags need to be loaded/unloaded promptly.

This includes suitcases, large duffle bags, & any other type of carry on.

Violation of any of these rules could be cause for dismissal from the bus.

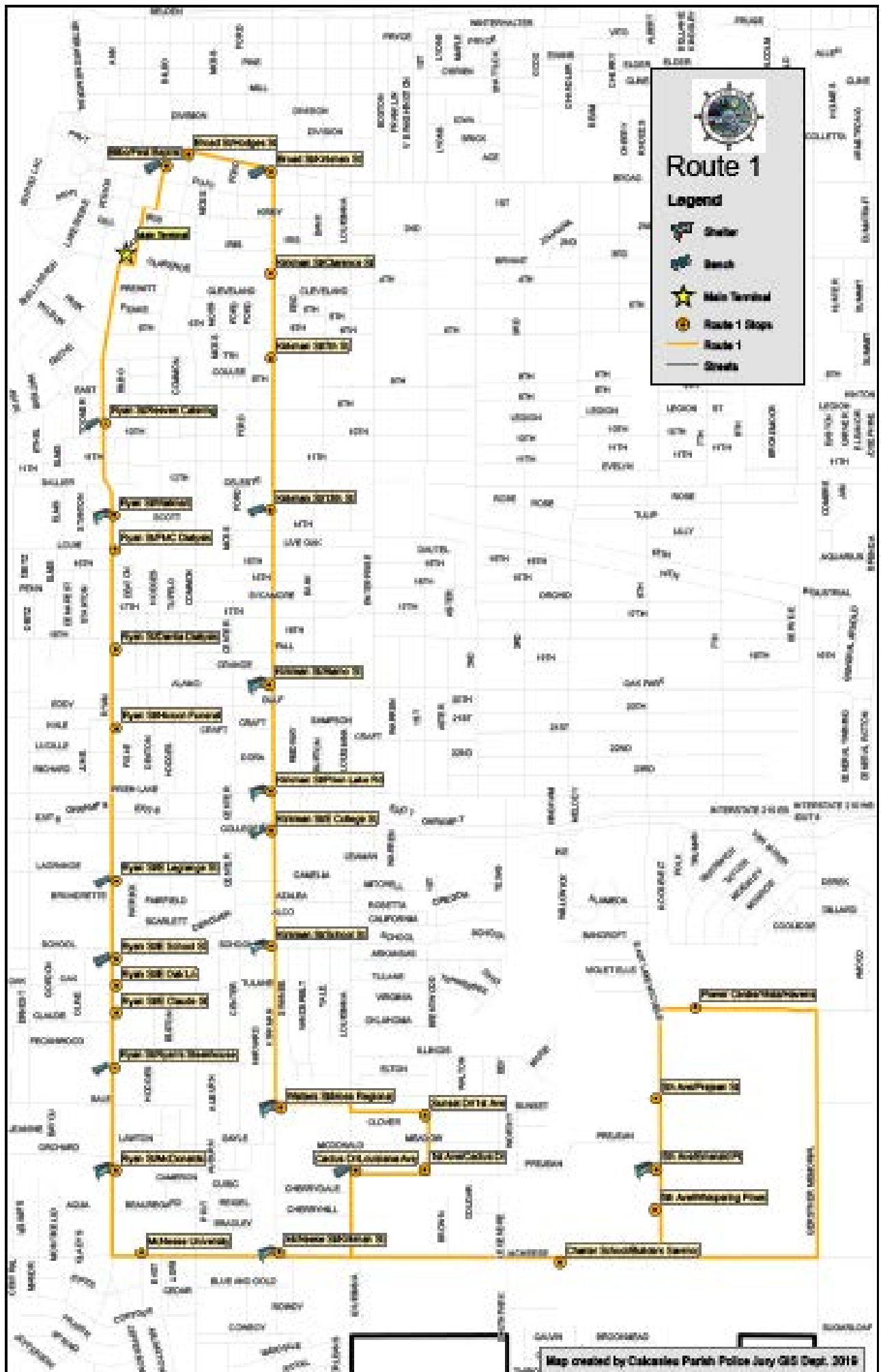

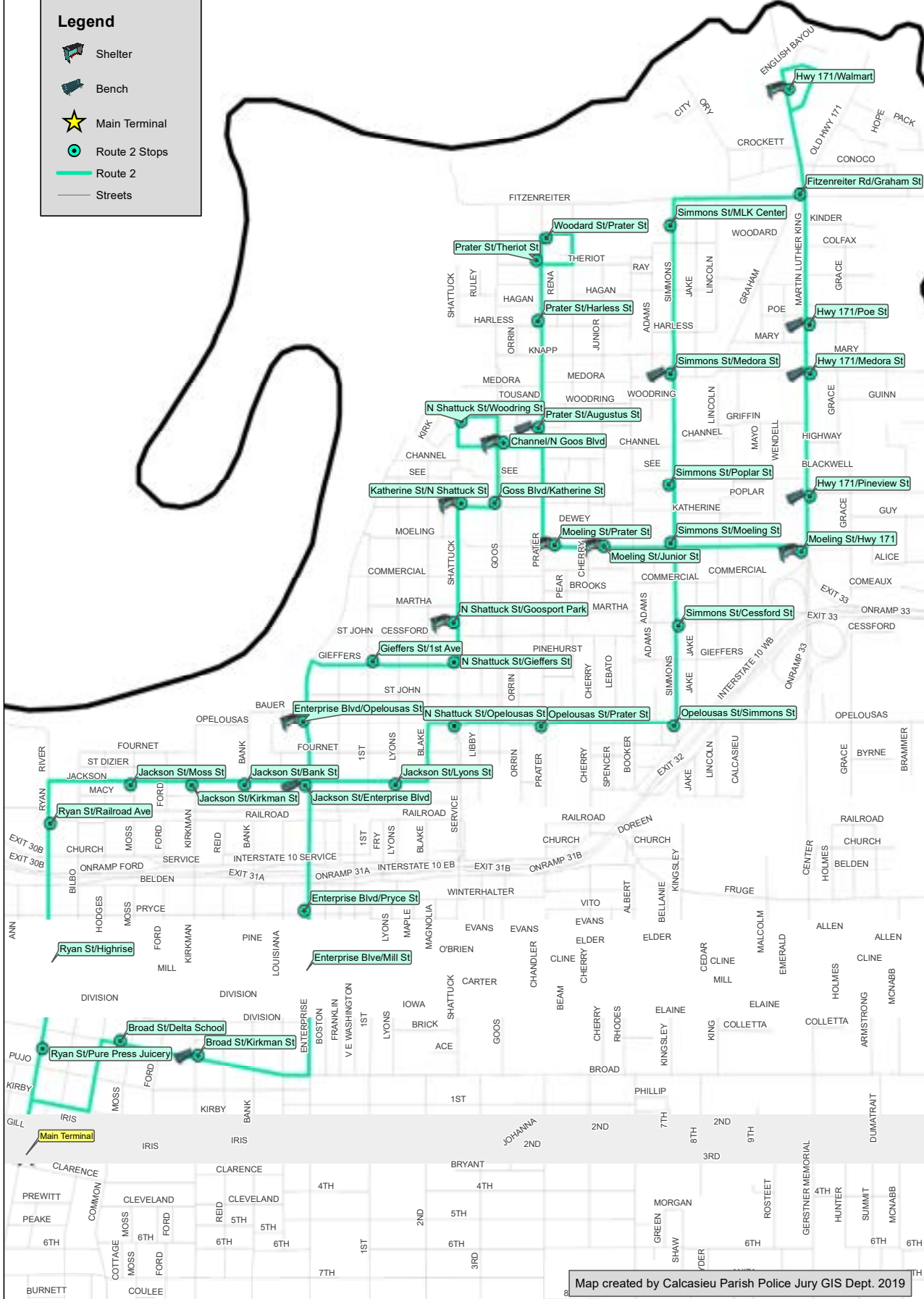




Route 2

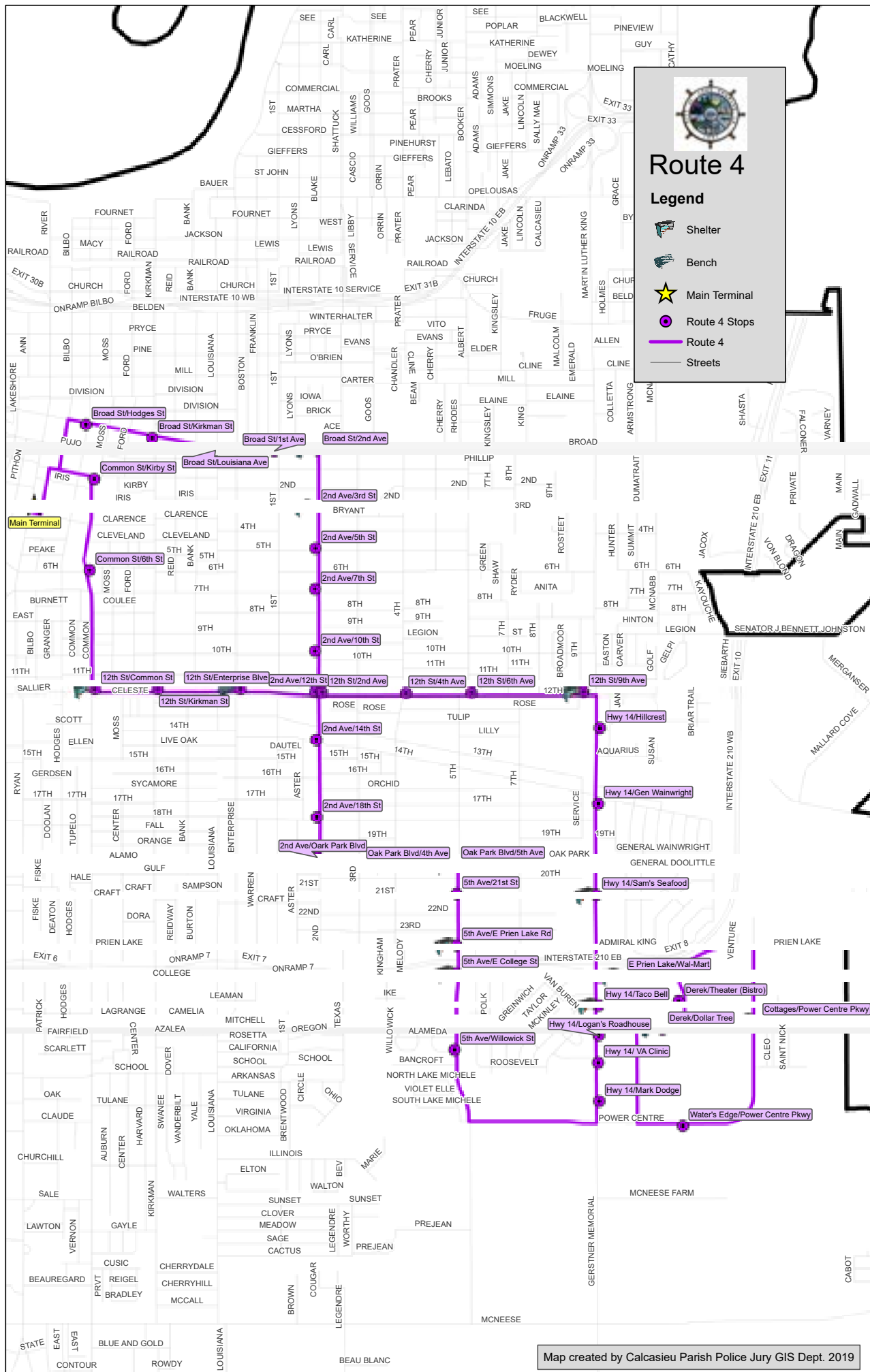

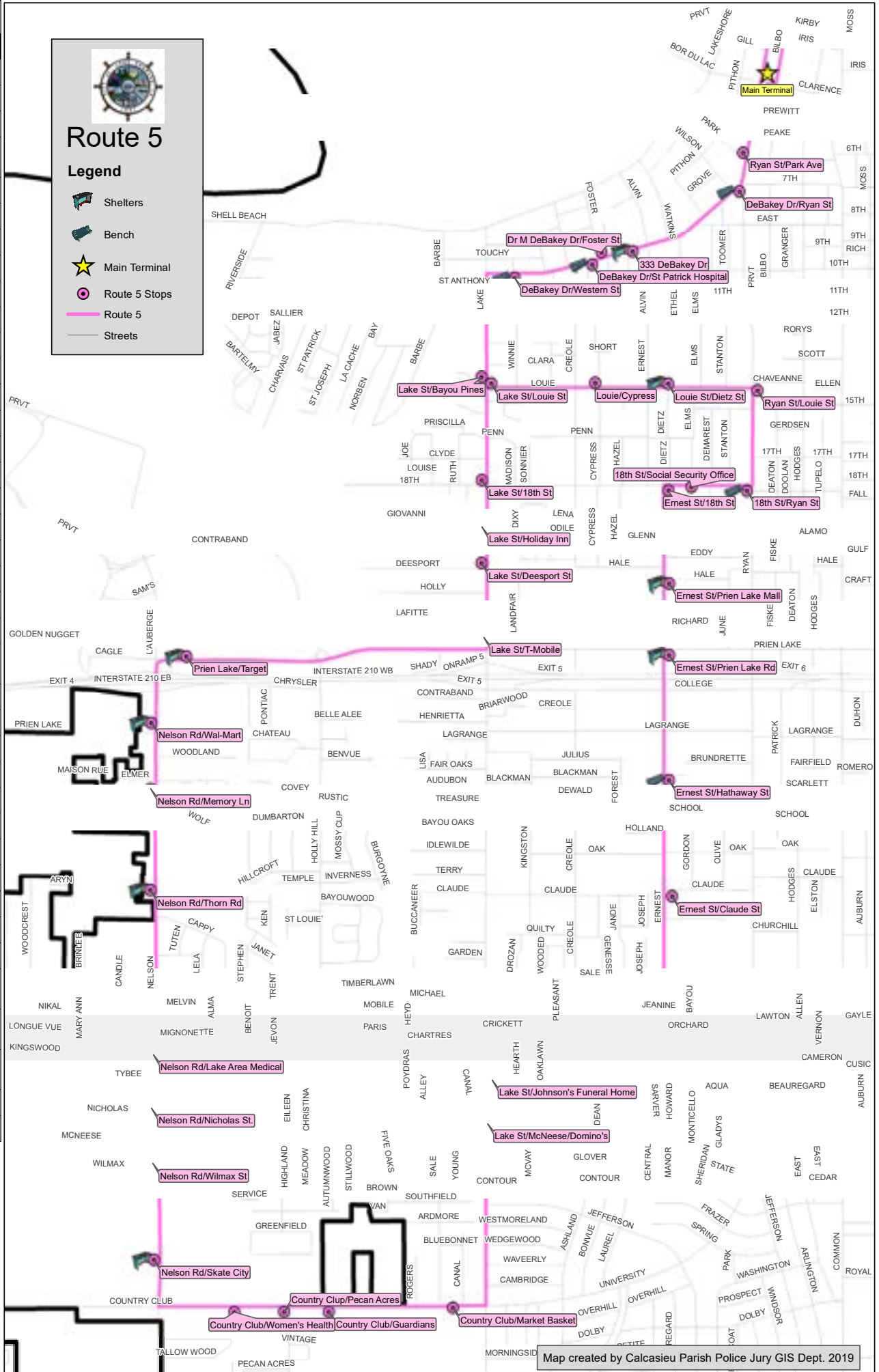
