

Lake Geneva Winterfest Human Dog Sled Races

RULES

A Dog Sled Team will consist of 6 people (no more, no less):

- (4) people pulling the sled
- (1) person riding the sled
- (1) "musher" to ride on the back on the sled*

The Rules

The Lake Geneva Winterfest Human Dogsled Races will be limited to **16** teams on a first come basis. The races will take place on a 50 yard straight away track on Riviera Beach. **Teams are required to pre-register for the race event by 11:59 PM on Friday, January 31**. <u>ALL participants MUST sign a waiver!</u>

- The race will be run in a single elimination bracket.
- No member of the team is allowed to wear shoes with metal spikes/cleats
- Each team must start behind the starting line.
- The "Musher" may push-start the sled up to the start line.
- Once the sled has crossed the start line, the "Musher's" feet must remain on the sled in order not to aid the sled across the finish line.
- The entire team must stay within the race lane. Any team, or part thereof, that enters the opposing team's lane may be disqualified.
- The "Rider" must remain on the sled for the entire race.

Any infraction of the rules above may result in team disqualification

Equipment & Attire Recommendations

- The Sled* and Harness: Are provided by VISIT Lake Geneva
- Footwear: Weather appropriate shoes/boots with good tread are encouraged, any type is permissible (see rule above regarding metal spikes).
- Clothing: Costumes are encouraged, please ensure that all team members dress appropriately for the weather.
- Safety: Face, eye, and hand coverings are encouraged, especially if temperatures warrant protection against wind and frostbite.
