Safety Tips

- Do not enter closure areas. These areas are closed due to on-going wildfire hazards. Check www.fs.usda.gov/willamette for updated closure information.
- Most of our roads are single lane with turnouts and are not maintained for snow or ice. Remain alert for other vehicles and stay as far to the right as possible.
- Carry a shovel and tire chains with you at all times and know your vehicle capabilities in adverse driving conditions.
- We recommend driving with your lights on to increase your visibility. Remember to turn them off when you leave your vehicle!
- Park your vehicle off the traffic lane to avoid blocking other motorists and set your emergency brake.
- In some areas 4-wheel drive vehicles may be required due to snow. **Don't exceed your vehicle's capabilities!**

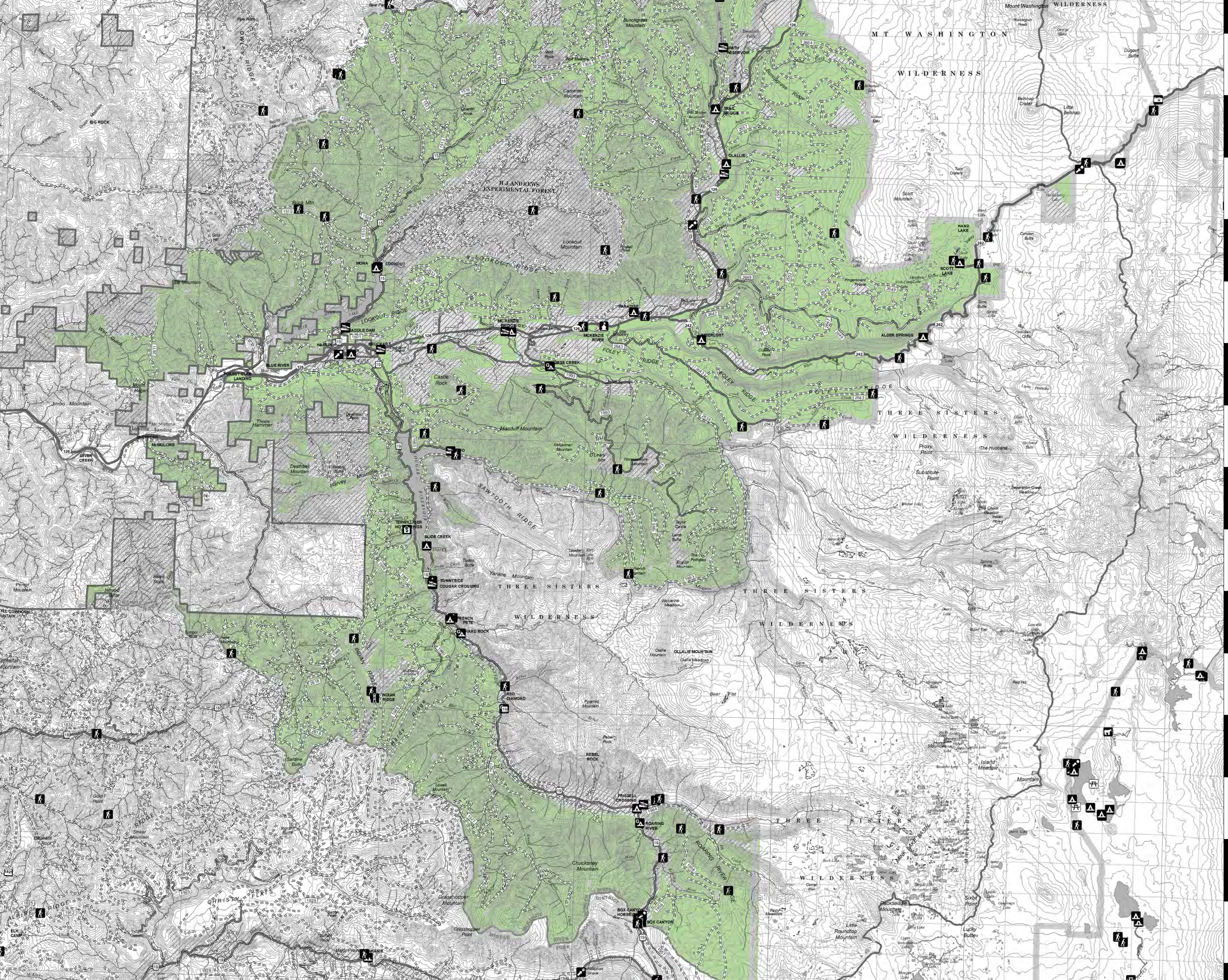
Sno-Park Permits
 Sno-Park Permits are required to park at designated and signed snow play areas on Highway 126 and Santiam Pass. Sno-Park Permits may be purchased at any DMV office, many ski and outdoor shops, and at some local stores. Sno-park permits are sold only at some Forest Service offices. Please call ahead to confirm availability.

Tree Permit and Selection

- Each purchased tree permit (\$5.00 / permit) allows the removal of one tree, **under 15 feet tall**.
- These permits are solely for personal use (not to be resold) and are valid only on National Forest land.
- Please select a tree within 12 feet of another to maintain a healthy population of trees.
- Once you have selected your tree, saw or chop the tree off within 6 inches of the ground and leave **No** live limbs attached to the stump.
- Before transporting your tree, validate your permit by writing the date and year or on the orange tree tags, tearing or punching out the date and year.
- If you have a permit from www.recreation.gov, display the permit visibly on your front dashboard.
- If you have an orange tree tag permit, attach the tag to the tree trunk between limbs and tie the tree down to transport. Permit must be visible during transit.
- A total of 5 tree permits per household are allowed.

Tree Cutting Restrictions

The following restrictions are designed to maintain scenic quality, prevent erosion and protect our resources:

- Christmas tree cutting is **prohibited** within 50 feet of trails and paved roads, within 300 feet of campgrounds, and within 100 feet of streams.
- No cutting is allowed in fenced plantations.
- Please do not cut in areas which are posted: "Christmas Tree Cutting Prohibited"
- Please keep all debris at least 50 feet from roadways.
- Five-needle pines, sugar and white pines are protected. **Please do not cut any of these.**
