

## 2025 Timber Rock Concert Ticket Sweepstakes

### OFFICIAL RULES

**ENTRIES ARE FREE OF CHARGE. ONE ENTRY ALLOWED PER PERSON. NO PURCHASE NECESSARY TO ENTER. ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED BY SPONSOR. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.**

By participating in the 2025 Go Laurel Highlands and Timber Rock Ticket Giveaway Sweepstakes (“**Sweepstakes**”), you agree to these official rules (“**Rules**”), inclusive of all terms and conditions. Please read the Rules carefully before participating. You must follow the directions provided within these Rules to be eligible to receive the Prize in connection with the Sweepstakes.

**SPONSOR:** The Sweepstakes is sponsored and administered by Laurel Highlands Visitors Bureau (“**Sponsor**”), 113 East Main St., Ligonier, PA., 15658.

**HOW TO ENTER:** The Sweepstakes will begin on the first day of the month at 9:00 AM ES prior to the month of the concert and conclude at the end of the month at 9:00 AM ES. (“**Promotional Period**”). To enter the website Sweepstakes, you must go to [golaurelhighlands.com](http://golaurelhighlands.com) and complete the registration form (the “**Web Entry**”). Those individuals submitting a completed Web Entry (the “**Entrants**”) agree to be bound by the terms and conditions of these Rules and will be entered into a random drawing as described in these Rules. To enter the Facebook contest, you must go the GO Laurel Highlands Facebook page and comment and tag #LHLiveMusic on the official contest post.

**ALTERNATIVE METHOD OF ENTRY:** Send a postcard with your full name, address, email address, and phone number to: Laurel Highlands Visitors Bureau. C/O Timber Rock Ticket Giveaway, 113 East Main St., Ligonier, PA., 15658 (a “**Mail-In Entry**”). Those individuals submitting a Mail-In Entry agree to be bound by the terms and conditions of these Rules and will be entered into a random drawing as described in these Rules.

Entries must be received by the end of the Promotion Period. Limit of ONE Entry per person. Multiple entries received from any person beyond this limit will void all such additional entries. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted.

Failure to follow any instructions provided in these Rules may result in disqualification. All materials submitted become the property of Sponsor, and Entries will not be acknowledged or returned. You are responsible for your costs of entering, including online access charges, etc. The time of receipt of any valid Entry shall be the

time such valid Entry becomes available to Sponsor. Sponsor's computer shall be the official clock of the Sweepstakes.

By entering this Sweepstakes, an Entrant gives express permission to be contacted by Sponsor.

**ELIGIBILITY:** The Sweepstakes is open only to a) legal residents of the fifty (50) United States of America and the District of Columbia, who are thirteen (18) years of age or older; and b) legal residents of Mexico, at the time of entry. Notwithstanding the prior sentence, this Sweepstakes is void where prohibited or restricted by law, rule or regulation. Officers, directors, and employees of Sponsor Entities (defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. "**Sponsor Entities**" shall mean Sponsor and its parent, subsidiary, and affiliate companies, and administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, promotion, or implementation of the Sweepstakes.

**PRIZE WINNER:** There will be one (1) Website Prize Winner ("**Prize Winner**") and one (1) Social Media Prize Winner, that will each be chosen on the day after the promotional period closes, at random from the pool of Entrants who have completed the required steps as of the end of the Promotion Period. Winning is subject to verification of eligibility.

**GRAND PRIZE:** Each Prize Winner shall receive two tickets to the advertised show at Timber Rock Ampitheater. The approximate retail value ("**ARV**") of the Prize is \$200.

**NO TRANSFER OR ASSIGNMENT OF THE PRIZE:** The Prize is non-transferable and non-assignable, with no cash redemption except at Sponsor's sole and absolute discretion. Odds of winning the Prize depends upon the number of eligible Entries received during the Promotion Period. Winner is fully responsible for any and all applicable federal, state and local taxes (including income and withholding taxes) associated with his or her acceptance of the Prize. All costs and expenses associated with Winner's participation in the Sweepstakes and/or acceptance of the Prize shall be the sole responsibility of the Winner unless otherwise provided in these Rules.

**NOTIFICATION:** Sponsor will notify the potential Winners at the email provided in the Entry for website entries and via direct message for social media entries. Sponsor will make three attempts to contact a potential Winner via email within 72 hours from the time of the drawing in which the potential Winner was selected. If Sponsor is unable to reach a potential Winner by email within such 72-hour period, then that potential Winner will be disqualified and an alternate potential prize Winner's entry will be drawn from all remaining eligible entries at random. At the time of Sponsor's contact with the potential Winner, the potential Winner will be asked to provide his/her proof of age, and a

government-issued photo ID. The notified eligible Winner shall be the only party eligible to claim the Prize.

If the Winner declines the Prize, fails to claim the Prize, is unavailable for prize fulfillment, fails to abide by the Rules, or is ineligible, Sponsor may select an alternate Winner from all remaining eligible entries. Sponsor is not responsible for and shall not be liable for unsuccessful efforts to notify a potential Winner.

**PUBLICITY RELEASE:** By submission of its Entry, an Entrant grants to Sponsor, and each of its respective designees, the right to use or publicize such Entrant's name, address (city and state of residence), voice, statements, photograph and/or other likeness (and as to the Entrant who wins, the right to use of the Prize information), for advertising, promotional, trade and/or any other purpose in any media or format now known or hereafter devised, throughout the world, in perpetuity, without limitation, and without further compensation, consideration, permission or notification, unless prohibited by law.

In addition, the Sweepstakes is in no way sponsored, endorsed, administered by or associated with Facebook.

Additionally, if the potential Winner is under the age of eighteen (18), or in the case of legal residents of certain states where the legal age of majority is greater than eighteen (18) years of age, if the potential Winner is under the applicable state's age of majority, the potential Winner's parent or legal guardian must execute a Parental Waiver and Release in the form attached hereto as Attachment A in order for such potential Winner be eligible to claim the Prize.

**GENERAL CONDITIONS:** Released Parties are not responsible for late, incomplete, illegible, inaccurate, undelivered, or garbled entries, interrupted or unavailable network

or other connections; misdirected, blocked, or delayed notifications; printing, typographical or other errors appearing within these Rules, in any Sweepstakes-related advertisements or other materials; or any other errors, problems or difficulties of any kind relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, or the announcement of the Prize or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to participants or to any other person's computer related to or resulting from participating in this Sweepstakes. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize (or any portion thereof), and (ii) disclaim any implied warranty. All disputes will be resolved under the internal substantive laws of the Commonwealth of Pennsylvania, without regard to its conflicts of laws principles, and the laws of the United States.
