 Approval of Minutes – May board meeting Action: Heidi moved; Danny seconded. Approved.

Mike reordered Executive Director item from five up to two.

- 2. Executive Director search
 - Mike announced that Kim Anspach has accepted the position of executive director
 - Will publish this in the near future
 - Mike offered to provide summary information about the search process to board members if anyone wanted more information
- 3. Finance Report Heidi Champagne
 - Met with Kim yesterday
 - Everything looked clean this month, not much to report
 - PPP loan funding was approved and is now forgiven
 - One unique item was Michael Davidson's party but not an issue
- 4. Quarter 2 Funding Update
 - Kim reported that when EL submitted the Quarter 2 request, EL was asked to provide an adjusted and reduced 'as needed' request due to the ongoing impact of the pandemic on hotel revenues and a reduction of funds in the Transient Guest Tax Fund.
 - The request went to the City Commission on June 8 (City Commission <u>Agenda Memo</u>) to approve \$192,210 and to loan the Transient Guest Tax Fund \$102,210 to cover the gap in the TGT fund.

- Two commissioners expressed concerns related to reserve funds and a grant that EL currently has.
- The City Commission approved a quarterly payment of \$142,210 to cover operating expenses and commitments which includes a loan to the Transient Guest Tax Fund of \$50,000 from the general fund.
- Kim is preparing for Quarter 3 and will look at options to reduce expenses as we continue emerging from the impact of the pandemic.
- Porter offered further explanation on the unique circumstances of the TGT fund; the fact that payment from the state is always one quarter behind and by state law, the city cannot spend funds until they are secured.
