## **Spot Sonia Terms and Conditions**

Here it is, the most hotly anticipated game of hide and seek around with the ultimate Eurovision prize... Spot Sonia!

Be in with a chance of winning a pair of tickets to the Eurovision Grand Final on 13 May at Liverpool Arena by finding all the hidden images of Sonia around the city.

Taking place on Friday 12 May from 11am here's how it will work:

- Players need to register in advance via this form here by....
- Those taking part will need to follow Visit Liverpool on socials (@VisitLiverpool on Twitter, @VisitLiverpool.com on Facebook and @visitliverpool\_ on Instagram)
- On the 12 May four separate clues will be released which will lead people to a location where an image of Sonia will be waiting.
- When each clue is revealed, the seekers have 90 minutes to find the location and take a selfie with the image.
- The image needs to be posted on social media, tagging in VisitLiverpool with #SpotSonia.
- Once all four clues have been completed, the players still in the game will be given a final secret location.
- The first 10 people to arrive at that location, with all their selfies to hand, will take part in one final task. The winner will be awarded two of the most sought-after tickets around.

## Terms & Conditions:

- 1. The competition is open to all aged 18 or over, except Culture Liverpool employees, contractors, their close relatives or anyone connected with the competition or the particular prize being offered.
- 2. A series of clues will be released via Visit Liverpool social media and will require the skill of the entrant to work out the individual locations, each hosting a Sonia cut-out with which they will take a selfie and tag @VisitLiverpool with the #SpotSonia. There will be four different locations in Liverpool City Centre, each with a time limit. Entrants will need to visit each location, take a selfie and tag, before the cut-out disappears.
- 3. There will be one final test at an end location. The first 10 people to arrive will take part with one winner to be awarded.
- 4. Entrants should take every care when traveling to the locations they believe have been revealed in the clues. The locations are all publicly accessible and pose no

specific risk to the general public. Liverpool City Council is not liable for any injury, loss or damage to property sustained by anyone taking part in Spot Sonia.

- Anyone not signed up officially via the Visit Liverpool website by 9am on Friday 12 May will be ineligible to win the prize even if they win the Spot Sonia challenge.
- 6. Following standard industry practice, Liverpool City Council may undertake background checks of the entrants that attempt the final test of skill. Information discovered, or that may have been disclosed by the entrants themselves may inform the decision as to whether they are eligible in accordance with these Terms.
- 7. Liverpool City Councils decision as to entrants and winner is final. No correspondence relating to the competition will be entered into. If the winner is later discovered as ineligible then the prize will not be won.
- 8. Entrants agree to take part in any publicity if required. Elements of the game may be filmed and broadcasted.
- 9. The prize is two standard entry tickets to The Grand Final of Eurovision 2023 (13 May 2023). Further information can be found at the respective event website. The prize may require collection or additional actions to be taken for fulfillment.
- 10. If the winner and/or their guest (if applicable) have any health or accessibility requirements, these need to be disclosed to Liverpool City Council prior to prize fulfillment. In order to fully experience the prize that includes experiences or ticketed events, there may be some Health & Safety requirements imposed by Liverpool City Council, the promoter or the venue. These will need to be followed prior to those elements being experienced. The winner and their guest (if applicable) must also comply with the health, safety and security policies at any venue associated with the prize.
