Purpose

The Livingston County Office of Tourism aims to offer grant funding that will assist Livingston County community groups, non-profit organizations, and tourism-related businesses in promoting and marketing festivals and events. Eligible projects include the hosting, coordination, and execution of new events as well as existing events with new enhancements to draw tourists to Livingston County and promote quality of life, outdoor recreation, cultural experiences, and agritourism. For purposes of these programs:

- An "Event" shall be defined as a new or existing organized music, cultural, film, food, or craft festival, community event, parade, lifestyle event, fireworks celebration, heritage event, agricultural event, concert, exhibition, celebration, flea market, and more which is conducted according to a prearranged schedule and is deemed to have the potential to attract visitation to Livingston County.
 - "New Large Festivals and Events" shall be defined as an event that is new to the region with the intention of becoming an annual event that will continuously grow and make enhancements year after year.
 - "Existing Large Festivals and Events with New Enhancements" shall be defined as an event that has previously been held in the region that has been temporarily canceled during the pandemic. These events should be returning to the area with new enhancements to improve visitor experience, increase tourist attraction and spending, and adapt to the new needs of safety due to the pandemic.
- A "Visitor" to Livingston County shall be defined as anyone who does not reside in Livingston County and who travels to the County for the purposes of recreation and/or business.

Program Description

Since March 2020, festivals and events in Livingston County have been postponed and adapted to the changing world while the way people attend events and seek out experiences has also changed. In addition to event and festival producers, countless vendors—many of whom are small business owners and employees—have been impacted by event and festival cancellations, including events vendors, managers, promoters, producers, artists,

designers, set-up crews, stage technicians, and events rental providers. Festivals and events contribute to the cultural fabric and vibrancy of the community and are a critical component of regional tourism.

The Livingston County Tourism Festivals & Events Fund aims to address the needs of event and festival producers seeking to reestablish community activities, events, festivals, and celebrations in a safe environment as well as establish new events that will enhance tourism and visitor spending in Livingston County. These events will engage residents, tourists, event workers, and working creatives while increasing the economic impact of visitors on regional and local economies, increase spending by visitors, generate media awareness of Livingston County, and enhance the quality of life for residents of Livingston County.

This program will make grants to non-profit organizations and for-profit businesses to produce new events and reestablish existing events with new enhancements that will attract visitors to Livingston County. Applications should spur innovation and strengthen the economy through the development and enhancement of the region's tourism and recreation industry. This fund focuses on high-quality, thoroughly-planned events that will draw tourists to the region when they previously would not have visited Livingston County. Funding is limited and will be awarded on a highly competitive basis.

Individual organizations and businesses can only receive one (1) grant per fiscal year. The fund will provide reimbursement of up to 50% of eligible projects. Funds awarded are paid to the grantee upon presentation of approved paid invoices.

Eligiblity —

Eligible applicant entities include community groups with a fiscal sponsor(s), non-profit organizations, municipalities, and tourism-related businesses. Businesses must be certified in New York State. Not-for-profit corporations are subject to New York State's Not-For-Profit Corporation Law and must have proof of incorporation (or an equivalent document) from the NYS Department of State or NYS Board of Regents, a charities registration number from the NYS Office of the Attorney General, and proof of tax-exempt status under the IRS code.

The following types of festival and event organizations will be considered eligible for an award.

- Eligible events must be located in Livingston County
- Festivals and events will take place between July 1st, 2022, to December 31st, 2022.
- Festivals and events that are open to the general public with the majority of attendees from outside Livingston County
- Agree to generate other funding (minimally 50% of expenses)
- Include the current Visit LivCo logo and link to VisitLivCo.com in all marketing assets.
- Develop a marketing plan that includes reaching outside a 30-mile radius of the local area.
- · Additional consideration will be given to shoulder- and off-season events
- Have contract(s) in place for event facilities and venues or, alternatively, letter(s) of intent reserving them

All applicants who receive funding must meet with the Livingston County Director of Tourism, Melissa Hughes to discuss their event and detail the marketing plan for the event.

Ineligibility

Types of events that do not qualify for this funding include:

- Fully-virtual events
- Events already receiving or eligible for federal ARPA funding for the same purpose or use (e.g. farmer markets, food drives, health fairs, and other resourced events)
- Religious or political events
- · Yard sales
- · Business meetings, conventions, conferences, trade shows, and expositions
- Third-party promoters, site selectors, and commissions

Use of Funds

Funds will be provided as a reimbursement for eligible expenses, not to exceed 50%. Eligible expenses must be incurred after receiving and signing a certified award letter. Eligible expenses include:

- Fees and rental expenses including venue and vendor rentals; equipment rentals; performer and vendor fees; licenses, permits, or insurance costs; travel and lodging expenses for vendors or performers
- Service and staffing expenses including security and valet costs; payroll for staff beyond regular employees already employed by the business or organization
- Promotional items and supply expenses that are not resale including consumable goods used at event; materials and products used to enhance the event
- Marketing and branding expenses including printing of posters, tickets, banners, wayfinding, etc.; design of event logo, posters, advertisements, promotional items, etc.; paid marketing and advertising via television, radio, social media, print, and digital platforms

Ineligible expenses include but are not limited to: fundraising; prize money; acquisition of land or buildings; promotion of state public officials individually named; lobbyists; political contributions; late payment fees; finance charges or contingency funds; parking or traffic violations; payment of tax obligations or charitable contributions; payment of debt. Promotional items for resale are not eligible.

If you are unsure if an expense is eligible, it should be discussed with Livingston County Tourism prior to order.

The funding amount of each award will be determined based on the total number of applications received, the total amount requested by applicants, and the application score determined by a review panel. All awards are based on available funding.

Application Deadline _

Applications will be accepted from Wednesday, May 25th, 2022 and to Friday, June 24th, 2022. Applications will be reviewed by committee.

Reimbursement Procedures

Funds shall not be provided in advance of project completion or full payment for the project by the recipient. Once the applicant provides verification that the project has been completed and that all vendors have been paid in full, reimbursement will be processed. Applicants must document project expenditures and the required match to receive reimbursement. Proof of payment to the contractor/vendor is required in the form of an invoice and cancelled check or credit card statement. Cash payments are not an acceptable form of payment and cannot be reimbursed. Sales tax is not a reimbursable expense. Only those costs deemed to be reasonable and appropriate to complete the project which was approved and agreed upon will be reimbursed.

Livingston County Tourism reserves the right to amend or change the Festivals & Events Fund, its rules or organization at any time without prior notice.

The applicant is responsible for the submission of a complete application including the application form and all supporting documents listed below:

- Completed application and event timeline
 - Marketing plan that includes reaching outside a 30-mile radius of the local area
- Contract(s) for event facilities and venues or, alternatively, letter(s) of intent reserving them
- Documentation to support visitor attraction from outside Livingston County including marketing and advertising collateral from past events or for the event in the application
