The Wisconsin Sand Sculpting Festival is in collaboration between:



- Vendors will be limited to the first 20 paid applications
- Vendor fee is \$100.00 (10x10 space) and must be submitted with your application to reserve a space. If vendor is not accepted, the check will be returned.
- Vendors are required to have their own tents, anchored down with weights. Staking in cement is not allowed. In the case of high winds or bad weather, the vendor is liable for the security and safety of their structures and anything within.
- Vendor Set Up is: Saturday and Sunday 8:00am-9:30am. No vendor vehicles will be admitted after 9:30am on both days. If leaving at the end of the day with your vehicle, NO vehicles will be able to leave the gated area until "after" the event ends.
- Vendors are responsible for cleaning up their vending area before leaving.
- Vendors must abide by all applicable local, state, and federal licensing and regulations.

Sunday	July 19, 2026	10:00am-5:00pm
