#### **NEW BUSINESS**

A. Tradeshows, FAMs and Client Events

Mark McMinn led a discussion regarding tradeshow, client event and FAM planning and logistics. Mark advised the committee to route all feedback regarding events to him or another MCCVB staff member. Discussion ensued.

Recommendation made to create a matrix of tradeshows and dates to provide to committee members to view availability, gauge interest and create a heat map for what shows are most popular. MCCVB to also provide committee with historical cost to ROI data on the shows we participate in. In regards to booth design iconic images are preferred, MCCVB to bring examples of booth design to November meeting.

Client events also discussed with the recommendation made to solicit feedback from partners on what dates and locations best accommodate those interested in attending.

Positive feedback was received for FAM's brought to the destination with a preference to divide by territory and actively qualify clients that best fit the destination's needs.

Three tasks forces were formed; Tradeshows, FAMs/Client Events and PCMA Convening Leaders Tradeshow in January 2020. The scope of work of the task forces are to review MCCVB boot/event design, logistics, recruitment, provide feedback and report recommendations to the overall committee.
