



MORGAN COUNTY CONVENTION & VISITORS BUREAU Tourism Enhancement & Development (TED) Fund

The TED Fund has been created in order to allow for a funding process whereby the Morgan County Convention & Visitors Bureau (Visit Morgan County) may invest in quality local projects that meet our mission. This program seeks to promote and encourage the enhancement and development of tourism related projects within Morgan County, thereby improving both the quality of visitor experiences and the quality of life for residents of the county.

The TED Fund will provide funding toward projects that can demonstrate a positive impact on Morgan County tourism and support current tourism strategies and initiatives. Highest consideration will be given to projects that will generate new visits and overnight stays, extend current stays in Morgan County or draw significant tourism related investment or press coverage to the area. Funds may NOT be used for general operating expenses, maintenance or other ongoing annual expenses.

All projects are subject to approval by Visit Morgan County and the Morgan County Convention, Visitors and Tourism Commission (MCCVTC), and exceptions to the criteria above may be made solely at the discretion of the MCCVTC.

The fund is maintained by Visit Morgan County and can be accessed for qualifying projects as needed and as the fund balance allows. Contributions to the fund will be made as needed and as budgets allow. Applications for funding through the TED Fund may be made at any time, however approvals may be restricted until additional funding is available, should the fund balance drop below a minimum level. Visit Morgan County reserves the right to disqualify any applicant or application for any reason.
