2024 Destination North Myrtle Beach Legislative Priorities

Destination North Myrtle Beach works with its board of directors and public policy committee to advance positions on local, state, and federal issues along with legislation impacting area businesses. Our investor/partner driven advocacy efforts are helping to ensure full economic prosperity and quality of life for the area.

Destination North Myrtle Beach will:

Tourism

Advocate for "Tourism Friendly" legislation which will help increase tourism in North Myrtle Beach

Advocate for fairness in the short-term rental industry to enact checks and balances on VRBO and Airbnb class of businesses

Support homeowner rights allowing short-term rentals, unless restricted in areas governed by Home Owner Associations, while advocating for the collection of all appropriate taxes

Advocate for the local municipality to require short-term rental owners to provide a local contact and to obtain a South Carolina issued short-term rental permit

Advocate for the review and oversight of the accommodations tax allocations each year to ensure they are spent as intended

Advocating the school start date be no earlier than the 3rd week in August

Advocate for a new state park on Waites Island along Little River Neck Road

Advocate for the enforcement of the South Carolina Real Estate Commission rules and regulations

Economic Development

Support efforts and policies that are used to advance economic development and entrepreneurship

Advocate for legislation to clarify the policy of the General Assembly to have a "modified joint and several liability" system

Support efforts to lessen and minimize regulations on businesses

Advocate for and support efforts and legislation for attainable workforce housing

Advocate for the expansion of capabilities for natural gas Support efforts for funding for beach renourishment and dune recovery

Advocate for the expansion of wind power opportunities in the state

Advocate for local businesses to use the state's Apprenticeship Carolina Program

Support efforts by area officials and Santee Cooper in the installation of electric charging station opportunities

Support the construction of Interstate 73

Support efforts to extend South Carolina 31 to the North Carolina border

Support efforts to extend South Carolina 9 to Interstate 95

Support efforts to improve SC 90

Encourage and advocate for Horry County Council to continue with priorities for paving, road improvements and to incorporate Coast RTA funding with RIDE IV projects

Advocate for continued funding for deepwater outfalls

Support the responsible management of natural resources to protect area neighborhoods
