Instructions

Who May File This Application. Any sales tax exempt governmental entity or sales tax exempt organization, other than the federal government and its agencies, that uses credit or debit cards which are directly billed to the exempt entity or organization to pay for its purchases of property, services, and lodging can file this application.

Purpose of Application. Upon approval of this Application, the Nebraska Department of Revenue will issue an exemption permit that can be used in conjunction with a <u>Nebraska Resale or Exempt Sale Certificate</u>, Form 13, and the credit or debit card identified on this application to purchase property, services, and lodging exempt from sales, use, and lodging taxes. This exemption permit will confirm that any purchases made using the identified credit or debit card will be directly billed and paid for by the sales tax exempt governmental entity or sales tax exempt organization.

Important: If more than one credit or debit card has been issued to the sales tax exempt governmental entity or sales tax exempt organization, a separate application is required for each card issued. The name on the card must match the name on this application. The exempt entity or organization is responsible for applying for a new exemption permit upon the expiration date of the current card.
