The meeting was called to order at 9:00 a.m. The Board then recited the Pledge of Allegiance, followed by a moment of silence.

**APPROVAL OF AGENDA**: Mr. Holland moved to approve the agenda. Second by Mr. Cafferty. There was no discussion. The motion passed unanimously (9-0).

**APPROVAL OF MINUTES:** Mr. Holland moved to approve the meeting minutes from November 18, 2021. Second by Mr. Bateman. There was no discussion. The motion passed unanimously (9-0).

**PUBLIC COMMENTS:** There were no public comments made. No written comments were received.

**STEERING COMMITTEE REPORT:** Lee Nettles reviewed the Tourism Impact Grant extension request from the Town of Duck. Mr. Bateman moved to grant an extension until to June 30, 2023 to the Town of Duck. Second by Mr. Fuller. There was no discussion. The motion passed unanimously (9-0).

Lee Nettles reviewed the draft timeline for the boardwalk at the Soundside. The Board felt the timeline was acceptable and gave staff the ok to talk to the Town of Nags Head and/or Dare County about a joint PARTF grant.

The Chair and Lee Nettles recognized outgoing Board members and thanked them for their service to the Tourism Board.

**BUDGET AND FINANCE REPORT:** Mr. Bateman reviewed the meals and occupancy receipts received. Receipts for fiscal year 2020-2021 are up 17.93% compared to 2019-2020 actual receipts. The Board discussed how the rental market was shaping up for 2022.
