November 2021 Non-Primary Residences by Location of Owner







Overview

The analysis was originally based on **73,458** Coachella Valley property data entries compiled by Visit Greater Palm Springs. The entries represented non-primary residence properties, identified as those reporting their home as non-owner occupied in the Riverside County property database.

The data was then converted into an SPSS statistical format by the Coachella Valley Economic Partnership (CVEP) to calculate and develop tables. After reviewing the entries, **4**,012 were eliminated that lacked classification data or with the same property and mailing address. The result is a net sample of **69**,**446** Coachella Valley properties, identified as both single family and condo properties (many in both categories with multiple owners).

The database included **42,973** (**58.5%**) single family and **30,485** (**41.5%**) condo properties. (Although owners may retain a post office box locally, there is no data to support that percentage.)

Key Findings



There are **73,458** total properties (**69,446** net sample properties after exclusions) in the nine cities of Greater Palm Springs



42,973 are single-family properties; **30,485** are multi-family condos



92% of properties are owned by U.S. residents,7% are owned by Canadians and less than 1% are owned by residents of other countries



For California ownership: Coachella Valley has the most owners (32.1%), followed by the Greater Southern California Region (Other Southern California, excluding Los Angeles) (28.4%), then Los Angeles County (27.5%), then Northern California (9.9%), followed by Central California (2.1%)

Non-primary residences by city show that **60% are in three cities**: Palm Desert **(23%)**, Palm Springs **(22%)**, and La Quinta **(15%)**.

States and Provinces Proportion of Remote Ownership



Remote Ownership by Zip Code





CONCLUSION: It's estimated that over 92% of non-primary properties are owned by US residents, while 7% are owned by Canadians, with less than 1% of owners being European or from other countries.



CONCLUSION: While California owners comprise an estimated 68% of total ownership, another 7% are estimated to live in Washington state and 3% in Oregon. Of the 7.2% of Canadian owners, an estimated 3.5% are from British Columbia and 2.5% from Alberta, the top Canadian areas.

CONCLUSION:

- Beyond local ownership, estimated ownership by city is statewide, mainly Southern California.
- Coachella Valley is estimated to lead with 32.1% of properties owned, 6.7% in Palm Desert and 6.4% in Palm Springs, with less than 6% in other area cities.
- Other Southern California (excluding Los Angeles) is next with an estimated 28.4%, 13.6% who reside in Orange County and 6.8% in San Diego.
- Greater Los Angeles represents an estimated 27.5% of ownership of properties, of which 7.5% is in Central/West Los Angeles and 8.9% in southern LA County areas.
