City/County agrees it will not unreasonably exercise this right of termination. *The parties hereto agree that the permittee, it's officers, agents and employees, in the performance of this permit shall act in an independent capacity and not as officers, employees, or agents of the City/County. *No alteration or variation of the terms of this permit shall be valid unless made in writing and signed by the parties hereto. *Permittee agrees to comply with the terms and conditions contained in the attached Exhibit(s), which terms and conditions are by this reference made a part thereof. *The permittee hereby agrees to comply with all the rules and regulations of the facility or institution subject to this permit. *Permit must be kept on-site at all times. *City/County make no representation or warranty as to condition of any property or facilities used by permittee, and it is the responsibility of permittee to fully inspect all such property and facilities to determine their condition prior to their use, and in going forward, assumes all risks associated with the condition of property or facilities.

2. Film/Video Production Permit Fee Schedule:

\$100.00 plus daily location fee

\$25.00 per day or \$125.00 per seven-day week

Every person transacting and carrying on the businesses enumerated in this section shall pay a license fee as follows:

Advertising.

- A. Billboards, signs not fixed on places of business: \$100.00 per structure or sign.
- B. Distributing handbills: \$100.00 annually, or \$50.00 monthly, or \$25.00 daily.
 - C. Sound trucks: \$200.00 annual fee per truck, or \$50.00 daily fee per truck.
- D. Klieg lights: \$150.00 per year per light, or at licensee's option, \$15.00 per day per light.

Auctioneers. Auctioneers not having a fixed place of business in the city, \$250.00 per year, or at the option of the licensee, \$25.00 per day.

Carnivals, Fairs. \$200.00 for the first day and \$150.00 for each additional day, for the first ten or fewer concessions; plus \$30.00 for the first day and \$20.00 for each additional day for each concession in excess of ten. For the purpose of this section, concession shall be any amusement ride, booth, exhibit, stall, tent, trailer, or stand which charges any fee for the ride, service or product offered.

Circuses. \$200.00 per day.

Commercial Filming. On city streets or other city property, as follows:

Persons Employed at Location	Rate per Day
13	- \$ 100.00
46	200.00
79	400.00
10 and over	600.00

Traffic-control costs or any additional costs as required by the chief of police shall be paid entirely by the applicant.

Contractors. Every person engaged in the business of contracting which requires a state contractors' license shall pay a business license as follows:

- A. General contractors, \$100.00 annual fee;
 - B. Subcontractors, \$50.00 annual fee;
- C. Business licenses for general contractors and subcontractors may be obtained semi-annually.

Living Accommodations. Every person transacting or engaged in the rental of four or more dwelling units in any apartment house, roominghouse, houses for rent, or other living accommodations shall pay an annual fee of \$12.00 per unit, provided that hotels and motels shall be on the gross receipts basis, Class B.

Mobile Home, Trailer and Recreational Vehicle Parks. \$12.00 per space per year.

Peddlers or Solicitors.

- A. Principal, \$200.00 annual fee;
- B. Each additional solicitor or peddler, \$10.00 quarterly.

Sales Representatives. Every person engaged in the business of solicitor of order for sales or services by a nationally franchised business (such as AVON) wherein solicitation only occurs by previous appointment, shall pay a business license fee of \$25.00 per year.

Taxicabs.

- A. Taxicab operator's license, \$60.00 annual fee;
- B. Taxicab vehicles, per vehicle, \$25.00 annual fee.
