**Park City Epic Local Merchant Pass** includes six discounted Ski-With-A-Friend and six discounted Buddy tickets. **Price: \$669** 

**Valid for**: Unlimited skiing or riding at Breckenridge, Keystone, Crested Butte, Okemo, Mount Sunapee, Stevens Pass, Afton Alps, Mt Brighton, Wilmot and Arapahoe Basin.

**Holiday restrictions at Park City**, Northstar, Heavenly, Kirkwood and Stowe. Also includes 10 days combined at Vail, Beaver Creek and Whistler Blackcomb with holiday restrictions. Perisher will **not** be included.

Restrictions: The pass is not valid at Park City, Northstar, Heavenly, Kirkwood, Stowe, Vail, Beaver Creek, and Whistler Blackcomb on the following dates: November 23 and 24, 2018, December 26 through 31, 2018, January 19, 2019 and February 16 and 17, 2019.

**Requirements**: Business must be a verified member of the Park City Chamber Bureau and must purchase the Merchant Pass for the employee. The pass holder must be an active employee of the business (will need proof of employment form or a paystub dated within the last two weeks at time of pass pick up).

Deadline for employer to purchase vouchers: 12/15/2018\*

How to purchase pass vouchers for your employees: Please visit a season pass office at the Park City Mountain Village (daily from 10 am to 5 pm) or Canyons Village Base Camp (starting in November, daily from 10 am to 5 pm). Payment can be made via cash, company check or credit card. All pass holders will be required to complete a 2018/19 season pass application and sign the release of liability.

\*Vouchers can be redeemed all season. Unused vouchers are eligible for refund prior to last day of the 18/19 season

Transferability: Yes. Business may request a one-time transfer to another employee for \$110.

# PARK CITY MOUNTAIN MERCHANT PASS PROGRAM DETAILS 2018-2019

**REQUIREMENTS**: Business must be a verified member of the Park City Chamber Bureau and must purchase the pass for the employee. The pass holder must be an active employee of the business (will need a letter from the business owner or a paystub dated within the last two weeks at time of pass pick up).

Unlike individual season passes, Merchant Passes are owned by the Business, which designates an employee as the passholder. If a passholder is no longer employed by the business, the business retains the Merchant Pass. The Merchant Pass is available for a one-time transfer to another employee.

All passholders will be required to complete a 2018/19 season pass application and sign the release of liability. The passholder is responsible for pulled or suspended passes. Any pass affected by these circumstances will not eligible for transfer or refund.

#### **EASY PASS PURCHASE PROCESS:**

- Company purchases voucher
- Company designates voucher to a particular employee by writing name on voucher
- Gives voucher and season pass application to the employee
- Employee redeems voucher with current paystub, ID and completed Season Pass application to receive pass

## WHY USE A VOUCHER?

- Business can pre-purchase pass vouchers prior to hiring employees
- Vouchers can be redeemed after general pass sales have ended
- Unused vouchers are eligible for refund prior to the last day of the season

The employee must bring the voucher, personal ID, completed season pass application and current paystub (or proof of employment from your company) to pick up their season pass.

**Holiday restrictions at Park City**, Northstar, Heavenly, Kirkwood and Stowe. Also includes 10 days combined at Vail, Beaver Creek and Whistler Blackcomb with holiday restrictions.\* Perisher will **not** be included.

Restrictions: The pass is not valid at Park City, Northstar, Heavenly, Kirkwood, Stowe, Vail, Beaver Creek, and Whistler Blackcomb on the following dates: November 23 and 24, 2018, December 26 through 31, 2018, January 19, 2019 and February 16 and 17, 2019.

- 50% off pass holder tickets available for purchase during blackout dates at Park City, Stowe, Heavenly, Northstar and Kirkwood.
- Full Passholder Rate during blackout dates at Vail, Beaver Creek, Whistler Blackcomb and beyond 10 days\*.
- \* For more than 10 days of access to Vail, Beaver Creek, and Whistler Blackcomb, ask us about the PARK CITY EPIC MERCHANT RESTRICTED PASS Price: \$899.

## DISCOUNTED LIFT TICKETS—6 Ski With A Friend Tickets AND 6 Buddy Tickets:

Passholder must bring their pass in person to a ticket window to get a discounted ticket. Payment does not need to be made by the merchant pass holder; friend or family may pay for the ticket. Passholder may use discounted tickets when pass is restricted.

## **PASS TRANSFER PROCESS:**

- Business calls the Park City Mountain Merchant Pass office at 435.604.3118 to deactivate passes of employees who no longer work for their company.
- Each pass may be transferred one time to another employee of the same business
- \$110 transfer fee to be paid with a business credit card or check
- Employee is required to present proof of Employment/Transfer form at a season pass office before transfer process can be completed.

#### **MERCHANT PASS REFUND PROCESS:**

- All applicable refunds will be given to the Merchant, not the pass holder.
- Unused, Pre-purchased MM Vouchers Full Refund prior to last day of winter season
- A refunded Merchant Pass is not eligible for transfer
- Merchant Passholder refunds may be given if passholder becomes a Vail Resort Employee
- Epic Passholders who receive a Merchant Pass are eligible for a refund per the time line below
- Refund time line:
  - 100% refunded if request for refund is prior to December 31st
  - o 50% refunded if request for refund is from January 1st thru March 16<sup>th</sup>
  - No refund after March 16<sup>th</sup>
