Not Applicable Construction of the Proposed Project would not occur on or seaward of any state beach. The Proposed Project would not adversely affect coastal areas that could jeopardize the stability of the beach-dune system, accelerate erosion, provide inadequate protection to upland structures, endanger adjacent properties, or interfere with public beach access.
Chapter 163, Part II <i>Intergovernmental Programs: Growth Policy; County and Municipal Planning; Land Development Regulation</i> requires the local governments to prepare, adopt, and implement comprehensive plans that guide and control future development toward the most appropriate use of land and natural resources in a manner consistent with the public interest. Chapter 252 <i>Emergency Management</i> provides for planning that would reduce the State's vulnerability to or impacts from natural or manmade disasters and would enhance recovery efforts in the event of such emergencies.	Consistent The Proposed Project does not increase the vulnerability of people or property to natural disasters. Emergency response and evacuation procedures would not be adversely impacted; although, the provision of additional efficient airport infrastructure may assist in staging or responding to emergencies.

Chapter 253 <i>State Lands</i> addresses the state's administration of public lands and property and provides direction regarding the acquisition, disposal, and management of all state lands.	Not Applicable Implementation of the Proposed Project does not require acquisition of or result in any impacts to state lands that would prevent the conservation, protection, enhancement, or preservation of State-owned natural areas, ecosystems, or archaeological and historical resources.
Chapter 258 <i>State Parks and Preserves</i> addresses administration and management of state parks, aquatic preserves, and recreation areas. Chapter 259 <i>Land Acquisition for Conservation or Recreation</i> authorizes acquisition to protect air, land, and water quality and abundance, and natural resource-based recreation opportunities. Chapter 260 <i>Florida Greenways and Trails Act</i> authorizes acquisition of land to create a recreational trails system and to facilitate management of the system. Chapter 375 <i>Outdoor Recreation and Conservation Lands</i> develops a comprehensive outdoor recreation plan to document recreational supply and demand, describe current recreational opportunities, estimate need for additional recreational opportunities, and propose means to meet the identified needs. Chapter 288 <i>Commercial Development and Capital Improvements</i> provides the framework for promoting and developing the general business, trade, and tourism components of the State's economy.
