I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

(A) A contract (Contract) with Rio-Bak Corporation (Rio-Bak) in the amount of \$426,085 and 146 Calendar Days for the Miscellaneous Drainage Repairs project at Palm Beach International Airport (PBI); and

(B) A Budget Transfer in the amount of \$55,233 in the Airport's Improvement and Development Fund, including a transfer from Reserves of \$55,233.

Summary: This project was advertised utilizing the County's competitive bid process. On March 31, 2022, two (2) bids were opened for the Miscellaneous Drainage Repairs project at PBI. Rio-Bak is located in Palm Beach County and has been identified as the lowest responsible/responsive bidder in the amount of \$426,085. This project consists of repair and replacement of existing drainage facilities at various locations within the property limits of PBI both inside and outside the airport perimeter security fence. The project was presented to the Goal Setting Committee on January 12, 2022 and an Affirmative Procurement Initiatives (API's) of 8% Small Business Enterprise (SBE) participation was applied. The Contractor has committed to 9.3% SBE participation. Pursuant to changes to Chapter 332, Florida Statutes, effective October 1, 2020, a governing body of a commercial service airport may not approve purchases of contractual services in excess of the Category Five threshold amount of \$325,000 provided in Section 287.017, Florida Statutes, on a consent agenda. This contract exceeds the threshold amount and must be approved on the regular agenda. **Countywide (AH)**

Background and Policy Issues: This project consists of repair and replacement of existing drainage facilities at various locations within the property limits of PBI both inside and outside the airport perimeter security fence. The repairs include replacement of existing drainage structures and stabilization of the banks along drainage conveyance canals. These repairs will extend the life of the drainage structures and minimize the effects of future erosion. Builder's Risk Insurance is not required for this project.



Contractor agrees to accept as full compensation for the satisfactory performance of this Contract the sum of **Four Hundred Twenty Six Thousand Eighty Five and 00/100 (\$426,085.00), Total Bid Amount, Base Bid plus Additive Bid No. 1**. The prices named in the Bid are for the completed Work and all expense, direct or indirect, connected with the proper execution of the Work and of maintaining the same until it is accepted by the Board of County Commissioners. It is understood that the Contractor holds and will maintain current appropriate certification and/or license for the purpose of performing the specified Work pursuant to the Contract. The time limit for the Substantial Completion of all Work under the Contract shall be

as stated in the Bid Form. The date fixing the beginning of this period upon the calendar shall be established and stated in the Notice to Proceed.

The Governing Order of the Contract is agreed to be as follows: The Contract includes various divisions, sections and conditions which are essential parts for the Work to be provided by the Contractor. A requirement occurring in one is as binding as though occurring in all. They are intended to be complementary and to describe and provide for a complete Project. In case of discrepancy, the following precedence will govern the interpretation of the Contract Documents:

2. The Invitation to Bid and Instructions to Bidders;
3. Special Conditions;
4. General Conditions;
5. Insurance Certificates, Public Construction Bond and Guarantee
6. The Construction Documents

In the event that any conflicts cannot be resolved by reference to this Governing Order of Contract Documents provision, then Owner shall resolve the conflict in any manner which is acceptable to Owner and which comports with the overall intent of the Contract.
