RE: ACDBE Review - Invitation for Bid (IFB) No. PB 22-3, Rental Car Lease and Concession at the Palm Beach International Airport

A total of eight (8) bid packages were received and reviewed in response to IFB No. PB 22-3, Rental Car Lease and Concession at the Palm Beach International Airport.

Bids submitted by **Avis Budget Car Rental, LLC (Budget/Payless)** and **Avis Budget Car Rental, LLC (Avis/Zipcar)** have been found non-responsive for failure to submit evidence of good faith efforts to achieve the ACDBE goal. Schedule 3 documentation in both submittals was incomplete; further, three (3) sections of the Schedule 3 form had been left completely blank.

The remaining six (6) bids are responsive to the IFB and each bid has satisfied the ACDBE requirement by meeting or exceeding the participation goal of 3.22%.
