### ***Hospitality Relief programs***

#### **For Employees:**

- **Hospitality Assistance Response of PA (HARP):** <https://www.prla.org/harp.html> - *The Hospitality Assistance Response of Pennsylvania (HARP) is a 501(c)(3) that provides immediate emergency funding to hospitality workers. Funded by private, community, and individual donations, HARP will distribute one-time individual grants to our front-line industry employees during times of unforeseen hardship. Grants will be awarded on a first-come, first-served basis and subject to the availability of funds at the time. Applications available soon.*
- **Restaurant Strong Fund:** <https://www.restaurantstrong.org/index.html>- *To qualify for grant assistance, you must satisfy all of the following requirements: Completed Application Form, Full-time employees (Minimum of 30 hours total per week, can be multiple restaurants), Employed for 3 months or longer at the same location, Worked in a restaurant, bar, cafe or nightclub located in; (Pennsylvania & 19 other states), Submit the last two full-time (30 hour) pay stubs*
- **Restaurant Employee Relief Fund:** <https://rerf.us/apply-for-aid/>
- **Bartender Emergency Assistance Program:** *Servers and bartenders may apply but only if the restaurant has a full liquor license. Spouses and children of bartenders may also apply (one application per household) - Staff only need their most recent paystub to apply, any additional documentation proving their hardship is optional - Maximum grants are \$2500*

- **Golden Rule Charity:** <https://www.goldenrulecharity.org/grant-application> - *Grants solely for any hospitality workers - Staff must be on payroll for minimum of 6 months to apply - Application will ask for copies of bills that need to be paid, police reports proving theft, auto incident reports if applicable*
- **One Fair Wage:** <https://ofwemergencyfund.org/help> - *Specific grant for COVID19 - No maximum dollar amount listed*
