Marine Safety Information Bulletin (MSIB) 22-007, POTENTIAL TROPICAL <u>CYCLONE 1</u>

Weather Advisory Port Condition WHISKEY - 24 HOUR ALERT Time: 1:00 P.M. / Date: June 3, 2022

Based on the National Hurricane Center forecast issued at 10:00 A.M. on Friday, June 3, 2022, Potential Tropical Cyclone 1 is approximately 300 miles southwest of Florida moving North East at 5 mph with max sustained winds of 40 mph. The forecast indicates sustained tropical storm force winds (39-73 mph / 34-63 knots) may arrive in South Florida within 24 hours.

As a result, the Captain of the Port (COTP) has ordered **Port Condition WHISKEY** beginning at 1:00 P.M. June 3, 2022 for the following areas:

Miami River, Port of Miami, Port Everglades, Port of Palm Beach, Port of Ft. Pierce, and all remaining terminals and facilities within Sector Miami's area of responsibility.

Prohibited Operations: None at this time.

Current Actions:

- Waterfront facilities should remove potential flying debris, hazardous materials and oil pollution hazards from dockside areas.
- Waterfront facilities should clear open areas on docks, wharves, and piers of all missile hazards.
- Waterfront facilities should notify the COTP of any labeled dangerous cargo, which must remain in open areas because of insufficient shed space or storage regulations. Items such as drums should be banded on pallets or laid horizontally with secure dunnage.
- Container terminal operators should implement container-stacking plans. General cargo container
 stack heights shall be reduced to no more than two high for containers containing hazardous materials,
 no more than four high for all other containers, or propose alternate securing arrangements to the
 COTP.
- Remove hazardous materials from areas prone to flooding.
- All manned, self-propelled, oceangoing vessels moored or at anchor should set a navigation watch and maintain a listening watch on Channel 16 VHF-FM.
- Masters, owners, operators, or agents of oceangoing commercial vessels greater than 500 gross tons that must remain in port during the storm because of operational system problems, must request and receive permission from the COTP to remain in port before the setting of Port Condition X-Ray.
- The COTP shall be notified of all unmanned or "dead" vessels within the COTP Miami Zone.

- All practicable and reasonable measures should be taken to ensure maximum stability on all vessels.
- The COTP will conduct preliminary checks to discover unsafe conditions in port areas, especially in vulnerable areas. Maritime and port interests should conduct preliminary checks on their own and notify the COTP of any circumstances that cannot be corrected within 24 hours.
- All oceangoing commercial vessels completing cargo-handling or passenger operations should be
 prepared to depart the port as soon as possible and seek calm waters elsewhere if deemed necessary under
 future port conditions.
- All small craft owners should haul out trailerable vessels or seek appropriate safe haven per MSIB 20-007 titled *Heavy Weather Condition Safe Harbor Advisory*. This MSIB can be found in our homeport page: https://homeport.uscg.mil/port-directory/miami

Anticipated Actions:

All ports in the Miami COTP Zone should be following this storm closely. The COTP does not anticipate setting Port Condition X-RAY at this time.

At this time we do not anticipate any impacts or closures to bridges. Please remain aware that changes may occur as the storm develops.
